I hope everyone is having a great new year. Our Department Winter COA was held at the Renaissance Portsmouth Hotel. Overall, the responses to the new location have been very positive. The rooms, hospitality rooms, meeting rooms and banquet hall were great. The COA was very productive with some Department SOP changes and new Foundation By-Laws, Articles of Incorporation and Mission Statement being approved. In time, the new foundation will generate additional funds for the Department to better support our veterans, their families and our communities. There was a "lively" discussion of a proposed District 4 Resolution concerning the protection of monuments in the Commonwealth. Please educate yourself on the issue as we will most likely take the matter up again at our Convention in June. The banquet on Saturday evening was especially nice. Great atmosphere, food and fellowship followed by awarding our Patriots Pen (Ethan Avery – 1st Place; Anya Ambarish – 2nd Place; and Macon Landis – 3rd Place), Voice of Democracy (Emily Moore – 1st Place; Michael Koch – 2nd Place; and Timothy Cochran – 3rd Place) and Teacher of the Year (Patricia Elder – K thru 5; Sara Gibson – 6 thru 8; and Jeannine Chewning – 9 thru 12) winners. Thanks to everyone who made this awards program possible.

Overall, the Department is in good shape. Our membership goal this year is 32,575+. Currently, we need 3,445 renewals/new/reinstated members to reach this goal, which works out to be 21.66 renewals/new/reinstated members needed each day. Nine Posts have made 100% so far. Congratulation to Posts 7897, 8446, 7854, 4491, 9877, 3103, 5412, 3060 and 10826, you are leading the way! District 10 is ahead of all other Districts with 96.80%. Close behind are Districts 7, 8, 12 and 13...wonder which District will make 100% first? To make All-American this year we need to recruit 5% of the Adjusted Prior Year's membership as new/reinstated members. Currently, the Department stands at 4.12% and needs 288 new/reinstated members to reach 5%. To see where your Post or District stands look at the last column of your MEMSTATS report entitled N/R%. If you are at 3% or greater you are probably on track to make the 5% requirement. If not, you need to work your past due list harder and set-up some additional recruiting events.

As of January 22, Districts 2, 4 and 5 are 100% reported in Community Activity Reporting...way to lead the Department. For everyone else, you have until April 30<sup>th</sup> to complete you Community Activity Reporting. Let's not wait

until the very end to complete this task. You have proven you can do it for the past three halves. You know it is easy to do so let's "get 'er done!"

Looking at the District Performance Reports all the Posts and Districts have been inspected. Make sure you are cleaning up any discrepancies and forwarding any corrected or missing information to your District and State HQs. There are still a handful of Posts that need their Articles of Incorporation and current 990 information forwarded to HQ. This is particularly important and needs to be fixed ASAP. Also, there are 27 Posts with Post homes that State HQs does not have a copy of their insurance declaration page on file showing the Department and National VFW are additional insured. District and Post Commanders let's get this fixed right away. Call Kim at State HQ if you have any questions.

I have saved a special paragraph for audits. We had far too many September audits arrive <u>significantly</u> late to State HQs...this is not acceptable. Our National By-Laws require they be completed by the end of the month following the quarter. Post Commanders, make sure your audits are getting done on time. If a trustee is not available appoint a pro tem trustee. District Commanders, monitor your Post's audits and take action when needed. December audits are due by the end of January. No excuses, let's get them in on time!

We are starting to see this year's finish line. Review your Community and District Reports and make sure you are getting everything done. Monitor the MEMSTATS report and work your unpaid and past due list, and start planning some recruiting events. There is a lot of help available at the District and State levels so don't hesitate to seek assistance.

Thanks for everything you're doing to help our veterans, families and communities!

## 6. DIGITAL MEMBERSHIP CARDS:

Members now have the ability to download their digital version of their membership card. Depending on whether a member has an iPhone or Android, they will be able to download and access their digital membership card from the VFW app.

This will not replace the physical VFW membership card - we will still be sending out membership cards to all our annual and Life members. This is intended as another option for our members' convenience. When asked to show a VFW membership card, a member can either produce their physical card out of their wallet or display their digital card on their smart phone.

## 7. DUES NOTICE SCHEDULE:

Annual members will receive a *mailed renewal* notice five months, three months, and one month prior to their subscription end date. Annual members with a valid email address will also receive an *emailed renewal notice* six months, four months, and two months prior to their subscription end date.

Annual members will receive a mailed lapsed notice one, three, and five months following their subscription end date.

## 8. DUTIES OF TRUSTEES:

Attention of Post Commanders is directed to section 218 of the Manual of Procedure, "Duty of Trustees." Trustees Report of Audit must be completed in detail at the close of each quarter. Commanders are reminded that accurate and complete records shall be kept by all persons handling Post funds, including the Club Manager and Bingo Chairman. These records shall be audited by Post Trustees in the same manner as Post Quartermaster and Adjutant records.

## 9. E-MAIL ACCOUNT ACCESS:

All email accounts were reset so the new Officers could take control of their emails as of June 18<sup>th</sup>. This will be the primary means of sending correspondence from State Headquarters to Post and District Officers.

You will receive all General Orders, special notices and any other documentation that you need via email. This will help cut down on postal expenses and speed up the response time for you receiving the information.

Here are directions for logging into your new account for the first time.

1.Go to Department web site <u>www.vfwva.org</u>.

2. Click on Member Tools, Microsoft 365.

- 3. The user name is your email address; put that on the first line (see below for your new address).
- 4. Your default password will be Vfw2018# once you have accessed the mail program you will be asked to change it; it must contain at least one uppercase letter and one number.

For Post Officers, your address will be <u>cdrpost176@vfwva.org</u> where the 176 is you replace it with **your** Post number.

## 13. LIFE INSTALLMENT PROCESSING:

There is an important change that just came out for Installment Life processing...the Post Quartermaster can now process the Installment Life membership applications! We don't know if there is a no email option. In the meantime spread the word and please starting using this option. It should speed up the Installment Life processing time for our new members.

"Post level processing of Life member installments: When a Quartermaster signs up a new member there is a new selection for Installment Life. When that is selected the Quartermaster puts in the payment information and it generates an email to the member who must accept the terms from the link in the email. ## 14. MEMBERSHIP:

Commanders and Comrades,

We are beginning the critical period in our Membership Campaign for Mike's year. With five months remaining to reach 100% plus one, we have a lot of work ahead of us. The Department should be around the 90 percentile point as you read this. As most of you know the last ten percent is the most difficult to achieve. We can make it happen if we pull together as a team. I encourage all Commanders to include membership as a regular part of their meetings. All too often after the call for any applications for membership, nothing else concerning membership is discussed. We have to make membership a part of the agenda for each and every meeting. Commanders ask the members of your Post to help you attain your Post's goal of 100%.

The Membership workshop at the Winter Council was very interesting, as usual the comrades in attendance were very engaged and still asking questions as our time ran out. Many topics were discussed, but the one we spent most time on was the proper completion of the application. There have been changes from National on the electronic side and the paper application. Please make yourself familiar with these changes so you can continue to recruit successfully. Discuss this with your members at the next meeting to dispel any reservations they may have. Remember that many members of your Post working on membership makes your goal of 100% more attainable.

In last month's insert, I asked the District Commanders to present three Posts that we could bring up to or over 50 members to meet Nationals requirement for All American. I realize that not all Districts have a Post below 50 members. Several Commanders have talked to me about their Districts and we have targeted four Posts to work on. In some cases we have had to target a Post without contact with the District Commander; however we are here to assist and hope this will not create a problem. In the Third District we have picked Post 8356 West Point, they need 10 new or reinstated at this point. In the Sixth District we have Post 9877 Amherst, they need 2 new or reinstated. In the Eleventh District we have Post 4204 Hot Springs, they need 12 new or reinstated. In the Thirdeenth District we have Post 2044 Earlysville; they need 10 new or reinstated to reach one over 50. Surely out of these four we can get three over 50 members. Each year this is a requirement, or starting one new Post. Our pool of Post below 50 is getting smaller every year, and there are some Posts that will never reach 50, so in the near future we will have to start a new Post. Please be looking at areas in your Districts that can support a new Post. I think that may be the required next year.

The weather will be disagreeable for a couple of months, so let's review our unpaid list and contact or visit (my preferred method) these members and get them renewed or reinstated. As always the Team is ready and willing to help your Post succeed. Contact State HQ, any Line Officer, or any Team Member for assistance.

## 15. NATIONAL CONVENTION HOUSING:

119th National Convention housing will officially open February 20, 2018. Housing reservation information will be located on the convention website accessed through the main VFW website at www.vfw.org. The convention website will also have general convention information including the registration form and links to other convention related information for Kansas City, MO, July 21-25, 2018, including a tentative agenda.

## 16. NATIONAL CONVENTION REGISTRATION:

Section 222 of the Manual of Procedure states each Post will pay, in advance, a national convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the VFW National Convention. Each additional delegate attending the national convention will pay a ten dollar (\$10) delegate fee provided the Post has paid the mandated \$25 advance registration fee. All advance registrations should be mailed to the VFW National Headquarters, 406 West 34th Street, Kansas City, MO 64111, ATTN: Convention Registration or you may register on-line by going to www.vfw.org.

## **17. PARLIAMENTARY AUTHORITY:**

Procedure and Ritual establish that *Robert's Rules of Order, Newly Revised, 11th Edition* shall be the parliamentary authority on procedural matters not governed by VFW By-Laws and Manual of Procedure. ## 20. POSTS IN ARREARS FOR FINANCIAL OBLIGATIONS:

Attention is directed to Section 213 of the National By-Laws concerning any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in District meetings, County Council meetings (if applicable), District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

## 21. POW/MIA:

#### 12/12/2017 MIA Update

The Defense POW/MIA Accounting Agency has announced the identification and burial updates of eight American servicemen who had been missing in action from WWII, Korea and Vietnam. Returning home for burial with full military honors are:

**Army Air Forces 2nd Lt. Stanley F. Stegnerski**, 25, of Chester, Pa., whose identification was previously announced, will be buried Jan. 22 in Millsboro, Del. Stegnerski was a P-51D pilot flying out of Royal Air Force Base 244 at East Wretham, Norfolk, England. On Nov. 21, 1944, Stegnerski was flying a bomber escort mission when the

American aircraft were attacked by German fighters over Merseberg, Germany. Stegnerski's group closed in on a group of 20 German fighters and opened fire. He was last seen by his wingman as they prepared to attack the German Focke-Wulf fighters. A German shoot-down report noted a P-51 Mustang with a tail number similar to Stegnerski's had crashed on Nov. 21, 1944. The unidentified remains were buried in Grafentonna. Based on this information, and no information concerning Stegnerski as a prisoner of war, the Secretary of War declared him deceased on Nov. 22, 1945.

**Army Pfc. James J. Leonard**, Jr., 22, of San Francisco, whose identification was previously announced, will be buried Jan. 23 in his hometown. Leonard was a member of Company E, 2nd Battalion, 8th Cavalry Regiment, 1st Cavalry Division. In the early hours of July 20, 1950, Leonard's regiment arrived east of Yongdong, South Korea, and began preparing to assume the defense of the city. North Korean forces began attacking their positions on July 23 and took control of Yongdong by July 25. Leonard was reported as killed in action on July 25, 1950.

**Navy Reserve Chief Water Tender Paul R. Wright**, 41, of Meadville, Mo., whose identification was previously announced, will be buried Jan. 25 in the National Memorial Cemetery of the Pacific in Honolulu. Wright was assigned to the USS Oklahoma, which was moored off Ford Island, Pearl Harbor, when Japanese aircraft attacked his ship on Dec. 7, 1941. Wright was one of 429 crewmen killed in the attack.

**Navy Seaman 1st Class John E. Savidge**, 20, of Linden, N.J., whose identification was previously announced, will be buried Jan. 26 in the National Memorial Cemetery of the Pacific in Honolulu. Savidge was assigned to the USS Oklahoma, which was moored off Ford Island, Pearl Harbor, when Japanese aircraft attacked his ship on Dec. 7, 1941. Savidge was one of 429 crewmen killed in the attack.

**Army Air Forces 1st Lt. Ewart T. Sconiers**, 27, of DeFuniak Springs, Fla., whose identification was previously announced, will be buried Jan. 27 in his hometown. Sconiers served as a bombardier on the B-17F Flying Fortress with the 414th Bombardment Squadron, 97th Bombardment Group. On Oct. 21, 1942, his plane was severely damaged during a mission to bomb the German U-boat pens at Lorient, France. The crew parachuted safely and were rescued from the water, only to be turned over to German forces as prisoners of war. Sconiers was transferred to Stalag Luft II in present-day Zagan, Poland, where he remained until 1944. He was admitted to the camp hospital in January 1944 after a fall on ice. He was subsequently transferred to the reserve hospital in Luben, Germany (present-day Lubin, Poland), where he died on Jan. 24, 1944. He was buried by fellow prisoners in the POW section of the municipal cemetery in Luben/Schleswig on Jan. 27, 1944.

**Army Cpl. William C. McDowell** was a member of Company D, 1st Battalion, 32nd Infantry Regiment, 7th Infantry Division. In late November 1950, his unit was assembled with South Korean soldiers in the 31st Regimental Combat Team on the east side of the Chosin River, North Korea, when his unit was attacked by Chinese forces. McDowell was among more than 1,000 members of the RCT killed or captured in enemy territory and was declared missing on Dec. 2, 1950. Interment services are pending.

**Navy Fireman 1st Class Chester E. Seaton** was assigned to the USS Oklahoma, which was moored off Ford Island, Pearl Harbor, when Japanese aircraft attacked his ship on Dec. 7, 1941. Seaton was one of 429 crewmen killed in the attack. Interment services are pending.

**Air Force Col. Edgar F. Davis** was a navigator aboard an RF-4C Phantom fighter-bomber aircraft, assigned to the 11th Tactical Reconnaissance Squadron, 432nd Tactical Reconnaissance Wing. On Sept. 17, 1968, Davis was on a night photo-reconnaissance mission over Laos when he and his pilot were shot down by anti-aircraft artillery fire. While the pilot ejected and was rescued, no contact was received from Davis. After search and rescue efforts were suspended after failing to locate Davis or the wreckage, Davis was declared missing in action. Interment services are pending.

#### December 15, 2017 MIA Update

The Defense POW/MIA Accounting Agency has announced identification of remains and burial updates of eight American servicemen who had been missing in action from World War II and Korea. Returning home for burial with full military honors are:

**Army Sgt. Kermit J. Lejeune**, 23, of Church Point, La., whose identification was previously announced, will be buried Dec. 14 in his hometown. Lejeune was a member of Company K, 3rd Battalion, 35th Infantry Regiment, 25th Infantry Division. In late November 19`50, his unit engaged with Chinese forces in the vicinity of Unsan County, North Pyongan County, North Korea. Lejeune was reported missing in action on Nov. 28, 1950. Lejeune was later reported to have been captured and died in a North Korean POW camp in early 1951.

moored off Ford Island, Pearl Harbor, when Japanese aircraft attacked his ship on Dec. 7, 1941. Wilcox was one of 429 crewmen killed in the attack.

**Navy Mess Attendant 2nd Class Archie Callahan, Jr.**, was assigned to the USS Oklahoma, which was moored off Ford Island, Pearl Harbor, when Japanese aircraft attacked his ship on Dec. 7, 1941. Callahan was one of 429 crewmen killed in the attack. Interment services are pending.

**Army Air Forces 2nd Lt. Robert R. Keown** was a P-38 pilot assigned to the 36th Fighter Squadron, 8th Fighter Group. On April 16, 1944, Keown and three other aircraft escorted a B-25 medium bomber on an aerial search near the mouth of the Sepik River in Papua New Guinea. The fourship encountered heavy overcast conditions after charting their course home. Heavy rain forced them to turn toward the open ocean, where Keown and his wingman became separated from the other aircraft. His last known location was listed as more than a mile north of Yalu Point. None of the four aircraft returned from the mission. Interment services are pending.

**Army Sgt. 1st Class Milton M. Beed** was a member of Company A, 1st Battalion, 38th Infantry Regiment, 2nd Infantry Division. The unit was supporting South Korean forces in the village of Hoengsong, an area known as the Central Corridor in South Korea, when Chinese forces launched a massive counter-offensive, driving the support force to withdraw to Wonju. Beed could not be accounted for and was declared missing in action as of Feb. 12, 1951. Interment services are pending.

Colley was a member of Company C, 1st Battalion, 32nd Infantry Regiment, 7th Infantry Division. In late November 1950, his unit was assembled with South Korean soldiers into the 31st Regimental Combat Team on the east side of the Chosin River, North Korea, when his unit was attacked by Chinese forces. Colley was among 1,300 members of the RCT killed or captured in enemy territory and was declared missing on Dec. 2, 1950

"These numbers are an unprecedented achievement in the accounting mission's history," McKeague told the Honolulu Star/Advertiser. "This is without question a testament to the teamwork and tenacity of the entire DPAA team." McKeague added that DPAA fields more than 600 military and civilian personnel around the world, and is "committed to researching, investigating, recovering and identifying U.S. service members and civilians who made the ultimate sacrifice for our nation." Located at Joint Base Pearl Harbor-Hickam, DPAA'S facility also boasts an \$85 million identification laboratory. More than 400 personnel

Annually, the Veterans of Foreign Wars of the United States awards three individuals who are: Eagle Scouts, Girl Scout Gold Award recipients, Venture Summit Award recipients and/or Sea Scout Quartermasters who have risen above their peers in exemplifying the qualities of that rank. Awards are as follows:

\$5,000 1st place National scholarship \$3,000 2nd place National scholarship \$1,000 3rd place National scholarship

## **AM I ELIGIBLE?**

To be eligible for the award, the candidate must:

- Be a registered, active member of a Boy or Girl Scout Troop, Venturing Crew or Sea Scout Ship.
- Be the recipient of the Eagle Scout Award, Girl Scout Gold Award, Venture Summit Award or Sea Scout Quartermaster Award.
- Have demonstrated exemplary citizenship in school, Scouting and community.
