2. ACTIVE MEMBERSHIP:

The National Bylaws provide for only one type of membership: active membership. There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW Bylaws or procedures.

3. ALL STATE PROGRAM CHANGE:

POST 100% MEMBERSHIP AWARD - National is no longer carrying the 100% Membership Pins for the Post Commanders and Quartermasters. Post Commanders will still receive a Tumbler and the Vest if they are 100% by Tuesday, December 31, 2024, and Post Quartermasters will still receive the Tumbler.

4. BONDS:

All Bonds expired August 31, 2024. Please see July or August General Orders for the rate schedule for the cost of your bond and return completed form(s) and payment to State Headquarters. Please note the Quartermaster Bond rate schedule is for the Post Officers. There is a separate schedule for your canteen employees and others who are not Post Officers but need to be bonded. Remember that persons on any and/or all accounts have MUST be bonded.

EACH PERSON BONDED MUST BE ON A SEPARATE FORM. EXAMPLE DO NOT PUT QM AND COMMANDER ON SAME FORM, THERE MUST BE TWO FORMS COMPLETED BEFORE BONDS CAN BE PROCESSED. IF YOU ARE NOT SURE WHICH FORM, YOU SHOULD BE USING CONTACT STATE HEADQUARTERS.

5. BY-LAWS AND MANUAL OF PROCEDURE:

All officers should obtain current 2025 copies of the podium edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual. Copies of the revised edition of the Congressional Charter, Bylaws, Manual of Procedure

and Ritual are available through the VFW Store at National Headquarters. The 2025 revised edition reflects the amendments adopted by the 125th National Convention, which became effective on Aug. 28, 2024.

In 1994 President Bill Clinton passed through Joint Resolution designating December 7 "National Pearl Harbor Remembrance Day" and a formal part of our Patriotic, National Observances and Ceremonies codified in the United States Code (USC).

By the same token, we must remember our own government consigned **One Hundred and Twenty thousand** American born ethnic Japanese into detention camps. The most famous of which is Manzanar found at: https://www.nps.gov/manz/index.htm. Despite this maltreatment, some of those young "Manzanar Men, proved" their loyalty and volunteered to join the U.S. Army. A few were selected to form the famous 442nd "Nisei" Regimental Combat Team, which fought in Italy.

https://en.wikipedia.org/wiki/442nd_Infantry_Regiment_(United_States) Hard fought campaigns up the mountainous Italian peninsula including the attack on the Adriatic's Gothic Line, earned the 442nd: 21 Medals of Honor, 53 Distinguished Service Crosses, 371 Silver Stars, and 4000 Bronze Stars. Brave men who proved the metal of Asian Americans, please remember and pray for them in December.

On our Chaplains Corner website there is a tab called files. Inside there is a file "the VFW Pearl Harbor Day ceremony," which features intro and prayers for your chaplains to use in leading observances. I will create a refined version of the prayers for each commemoration so after a year we will have a library that can be used as needed. DUTIES OF TRUSTEES: 10.

Attention of Post Commanders is directed to Section 218 (a)(11) of the National Manual of Procedure, "Duty of Trustees." Trustees Report of Audit must be completed in detail at the closed of each quarter, one of which ends December 31, 2024.

Commanders are reminded that accurate and complete records shall be kept by all persons handling Post funds, including the Club Manager, Bingo Chairman and VFW Rider Groups. These records shall be audits by Post Trustees in the same manner as Post Quartermaster and Adjutant records.

Quarters ending March 2024 and September 2024 are NOW PAST DUE FROM SEVERAL POSTS.

11. FEDERAL FUNDING FOR POST:

"VFW and Auxiliary members will learn about the requirements for Auxiliaries, Posts, and Districts to apply for federal funding to include loans, grants, loan/grant combinations, and cooperative agreements. This includes various websites (SAM.gov, grants.gov, and websites for federal agencies), how to interpret federal funding announcements and federal regulations, and usual reporting requirements for those who accept federal funding. The course will be taught by an experienced federal funding specialist involved in funding programs who also manages millions in federal funding for multiple individual projects for a major federal agency."

12. **GENERAL ORDERS:**

The cut off for the General Orders is the 20th of the month. No EXCEPTIONS. Subscriptions for hard copy General Orders are \$30.00 for the year. Contact State Headquarters for more info.

13. **HALF-STAFF U.S. FLAG:**

Public Law 103-308, passed in 1994, designates December 7 as "National Pearl Harbor Remembrance Day" and requests the flag of the United States to be flown half-staff (sunrise to sunset) in honor of the individuals who lost their lives on that day. To order a flag, go to vfwstore.org/flags/usflags.

14. E-MAIL ACCOUNT ACCESS:

All email accounts were reset so the new Officers could take control of their emails as of **June 21**st. This will be the primary means of sending correspondence from State Headquarters to Post and District Officers.

You will receive all General Orders, special notices and any other documentation that you need via email. This will help cut down on postal expenses and speed up the response time for you receiving the information.

Here are directions for logging into your new account for the first time.

- 1.Go to Department web site www.vfwva.org.
- 2. Click on Resources, Microsoft 365.
- 3. The username is your email address; put that on the first line (see below for your new address).
- 4. Your default password will be **VFW2024!** once you have accessed the mail program you will be asked to change it; it must contain at least one uppercase letter and one number.

For Post Officers, your address will be <u>cdrpost176@vfwva.org</u> where the 176 is you replace it with **your** Post number.

16. IRS FORM 8822-B:

IRS Form 8822-B, it is now a requirement by the IRS that all Posts submit this form. This form must be submitted anytime the Post Quartermaster changes and/or the Post address changes. This has been effective January 1, 2014.

17. LIABILITY INSURANCE:

Posts with Post Homes must have liability insurance and list State Headquarters and VFW National Headquarters as additional insurers. State Headquarters does not need a copy of your whole insurance policy; only a copy of the Certificate of Insurance listing State Headquarters and VFW National Headquarters as additional insurers.

The Certificate of Insurance needs to be sent to State Headquarters every year and it can be emailed to statehq@vfwva.org, faxed 1-866-416-0586 or regular mail to VFW State Headquarters, 403 Lee Jackson Highway, Staunton, VA 24401.

Procedure and Ritual establish that *Robert's Rules of Order*, *Newly Revised, 14th Edition* shall be the parliamentary authority on procedural matters not governed by VFW By-Laws and Manual of Procedure. 30. VFW DAY OF SERVICE:

Post/District Commanders, and Comrades,

I wanted to make everyone aware of something that was brought to my attention for discussion and clarification. This is worth getting out now and re-enforced to our District Commanders and Post Commanders before May 2025 so you can plan for it.

One of the All-American Program requirements is to participate in the <u>VFW Day of Service</u>. This is how it's worded in the program book:

A Post must submit a community service report quarterly to their Department for submission to the All-American Dashboard. The quarters are July-Sept, Oct-Dec, Jan-March, and April-June. One of these community service activities must be for the VFW Day of Service. Learn more at: https://todaysvfw.org/vfw-day-of-service/

Even though it says to "submit a community service report quarterly **to their Department**", that's NOT how the VFW Day of Service is going to be recorded or tracked.

As per a conversation with Lynn Rolf, VFW Director of Programs, about what we may need to do to adjust our reporting from Virginia to handle this. He stated that Posts will be required to go to https://todaysvfw.org/vfw-day-of-service/ and enter their event using the "Sign Up Now" button. So, not only do they need to report this directly to National, but it's reported differently than Patriot's Pen, Voice of Democracy, etc. There also will **NOT** be a way of seeing who has or hasn't reported their event on the National Dashboard. Unless something changes at National between now and then, this is how this new requirement will be handled.

The Department IT Committee Chairman Robert "Check" Adamczyk updated the All-State and All-American page on the State website to show where to report it, but the key thing is that there isn't going to be a way to track it.

Therefore, consider this message an early "heads up" of what to expect in May 2025. Getting this news out to District Commanders and having them make sure the Posts understand this and when they submit the report to National. State Reps. need to remind the Posts/Districts when they do their first District meeting in 2025. The Day of Service is May 3, 2025. Since there will be no way for Districts or Departments to see who has and who hasn't met this requirement, it's going to be even tougher to track than usual.

31. VIETNAM WAR COMMEMORATION:

The following significant events occurred in December:

December 11, 1961 - The first U.S. Army helicopter units in Vietnam, the 8th and 57th Transportation Companies, arrive at the port of Saigon aboard the ferry carrier USNS Core. They are equipped with 32 CH-21 helicopters and 400 air and ground crewmen. Their presence is the direct result of the "limited partnership" between the Kennedy administration and Diem government.

December 24, 1961 - Specialist 4 George Fryett, a clerk for the Military Assistance and Advisory Group, Vietnam, is captured by Viet Cong troops while riding his bicycle on the outskirts of Saigon. Fryett, the first U.S. prisoner of war in Vietnam, is released six months later.

December 24, 1964 - Viet Cong agents detonate a vehicle filled with explosives at Saigon's Brink Hotel, which is being used as officers' quarters. The bomb destroys part of the building, killing two U.S. servicemen and injuring more than 100 people, including Americans, Australians, and Vietnamese. Four U.S. Navy nurses are wounded in the attack. At least one of them insists on treating victims at the scene and helping with disaster relief before accepting treatment for her injuries. All four wounded nurses receive the Purple Heart. They are the only Navy nurses to receive that award during the war.

December 28, 1964 - On December 28, the insurgency launches its largest attack to date when two Viet Cong main-force regiments, joined by local militiamen, overrun the town of Binh Gia, approximately 40 miles southeast of Saigon, in the Mekong Delta. The attackers occupy Binh Gia, which has a population of approximately 6,000 people, most of whom are Catholic refugees who fled the Communist regime in the North a decade earlier. Despite a numerical and technological disadvantage, the Viet Cong force holds Binh Gia for more than four days, repelling all South Vietnamese attempts to retake the town. The South Vietnamese military suffers heavy casualties, and 200 of them are killed, along with five American military advisers. The Viet Cong soldiers decimate a South Vietnamese ranger battalion as well as a battalion of marines before voluntarily abandoning Binh Gia on January 1, 1965.

The battle of Binh Gia is the costliest defeat yet for South Vietnam's armed forces in their fight against the Viet Cong insurgency. The battle demonstrates the increasing military proficiency of the Viet Cong. Perhaps more significantly, it shows that South Vietnam's military remains fatally weak, despite American resources and training, and that the Saigon government is unable to effectively defend the country, which seems dangerously near collapse.

December 2, 1965 - The aircraft carrier USS *Enterprise*, stationed at Dixie Station off the coast of southern South Vietnam, launches 21 aircraft in a strike against Viet Cong forces near Bien Hoa. In doing so it becomes the first nuclear-powered carrier in history to engage in combat operations.

December 8, 1965 - In Operation HARVEST MOON, U.S. Marines of Task Force Delta and other units combine with South Vietnamese army troops to engage the 1st Viet Cong Regiment. The operation takes place in and around the Phuoc Ha Valley, northwest of Chu Lai. When U.S. and South Vietnamese units are on their way to trap the Viet Cong regiment in the valley, enemy forces ambush the South Vietnamese troops. The Marines march overland to reinforce the South Vietnamese lines, then organize a counterattack. Marines waiting offshore aboard the helicopter carrier USS Valley Forge arrive as reinforcements. The fighting lasts until December 20, when the Viet Cong withdraw. HARVEST MOON becomes the Marines' largest engagement of the war since their arrival in Vietnam.

December 18, 1965 - The U.S. Navy establishes the River Patrol Force (Task Force 116) for Operation GAME WARDEN. The force's mission is to patrol the waterways of the Mekong Delta and disrupt Viet Cong activities and supply lines. U.S. naval commanders envision GAME WARDEN as an inland, riverine complement to the coastal interdiction of Operation MARKET TIME. Task Force 116 is equipped with a fleet of river patrol boats (PBRs). PBRs are shallow-draft, fast, and maneuverable craft used to intercept and inspect river traffic, sweep for mines, and support allied personnel on shore, including U.S. Navy SEALs. By 1967, the task force also utilizes UH-1 "Huey" helicopters of Navy Helicopter Attack (Light) Squadron 3 (HAL-3), known as the "Seawolves." Task Force 116 works to secure the major rivers in the Mekong Delta against enemy infiltration until December 1970.

December 1966 - In keeping with the large U.S. Army deployments to Vietnam throughout 1966, the 9th Infantry Division "Old Reliables" arrives in South Vietnam. The 9th is based in III Corps near Saigon, completing a ring of U.S. divisions that are assigned to protect the heavily populated capital region.

December 1967 - The final two brigades of the 101st Airborne Division arrive in Vietnam in December (the 1st Brigade has been in Vietnam since 1965). MACV assigns the newly arrived brigades to I Corps to counter growing enemy activity in the northern provinces.

December 1, 1968 - A total of 26 men of 4 Troop, First Ranger Squadron, of the New Zealand Special Air Service (NZSAS) arrive in South Vietnam. They are attached to the Australian Special Air Service at Nui Dat, in III Corps. While NZSAS detachments have previously served in Thailand, this is their first Vietnam deployment. They conduct long range patrols and ambushes against enemy supply lines. New Zealand's troop commitment in Vietnam peaks at roughly 550 personnel.

December 1, 1968 - Elements of the U.S. Army 9th Infantry Division begin an extensive counterinsurgency campaign against Viet Cong troops in the northern Mekong Delta. The operation, codenamed SPEEDY EXPRESS, lasts until the end of May 1969. Approximately 270 U.S. personnel are killed during operations. MACV reports almost 750 captured weapons and nearly 11,000 enemy casualties. Later, multiple journalists and others question the high ratio of enemy casualties to weapons captured, and some allege that a significant number of civilians were killed. Army officials reply that recovery of enemy weapons during the operation had been difficult due to the swampy nature of the terrain, the character of the fighting, and the number of engagements occurring at night or involving aviation units.

December 6, 1968 - Operation GIANT SLINGSHOT begins. It is an extension of SEALORDS barrier patrols that work to eliminate enemy riverine infiltration from Cambodia. GIANT SLINGSHOT personnel focus efforts specifically along the Vam Co Dong and Vam Co Tay Rivers, in the "Parrot's Beak" area of the South Vietnam-Cambodia border. The operation lasts until May 1970, when it is transferred to the South Vietnamese navy.

December 1, 1969 - In an attempt to introduce greater fairness into the system, the United States establishes a draft lottery. Under the previous selective service system, thousands of local draft boards, staffed by volunteers, produced draftees based on government quotas. Allegations that some boards practiced discrimination and favoritism contributed to growing public disaffection with the war.

Using the lottery system, officials choose capsules, each containing a day of the year, at random in public. They number the capsules in the order selected. Men with birthdays on the lower numbered dates are the most likely to be drafted. The lottery remains in force until 1973, but the effect it has on who serves in Vietnam is minimal because troop withdrawals have already begun.

December 26, 1969 - The SS Badger State, a civilian-owned 441-foot cargo vessel chartered by the U.S. Military Sea Transportation Service, encounters a storm in the middle of the North Pacific Ocean. It is carrying a cargo of munitions intended for delivery to South Vietnam. Several bombs in the hold break loose and explode. The explosion blows open the vessel's side, and the 40 members of the crew abandon ship. When a merchant ship arrives 30 minutes after the explosion, it recovers only 14 survivors.

December 1, 1970 - As part of the U.S. Navy's and Coast Guard's Vietnamization programs, Naval Forces Vietnam completes the three-month transfer of naval facilities at Phu Cuong, Long Binh, Kien An, Chau Doc, Tan Chau, and Ha Tien to Vietnamese navy control.

December 18, 1972 - When North Vietnamese delegates fail to return to the negotiating table, President Nixon orders the resumption of bombing in North Vietnam above the 20th parallel. In Operation LINEBACKER II—derisively nicknamed by some as the "Christmas Bombings"—the U.S. Navy and Air Force launch a series of devastating strikes against North Vietnam, mostly in the Hanoi-Haiphong area. The bombing operation, carried out primarily by B-52s, lasts for 11 days, with a 36-hour pause for Christmas Day. A total of 15 B-52s and 10 other U.S. aircraft are lost, primarily due to surface-to-air missiles. LINEBACKER II ends only after North Vietnamese officials agree to Nixon's terms for continuing peace talks. The United States continues to bomb North Vietnam south of the 20th parallel.

December 13, 1974 - The North Vietnamese Army 7th and 3d Divisions attack Phuoc Long, a provincial capital north of Saigon in III Corps. Attacking forces include multiple regiments of infantry, armor, artillery, antiaircraft, and sapper units. Defending South Vietnamese Army forces include 1,000 Montagnard Popular Forces troops, five battalions of Regional Forces, and four Territorial Artillery units. They are later reinforced by two battalions of the South Vietnamese 7th Infantry and additional artillery, ranger, and reconnaissance units from the regular South Vietnamese armed forces. A battle for the city rages for weeks. By January 7, however, the South Vietnamese defenders are overrun. Phuoc Long becomes the first South Vietnamese provincial capital to be permanently occupied by Communist forces. North Vietnamese troops also close in on Hue and other major population centers across Vietnam

December 31, 1974 - The size of the reduced U.S. military mission to Vietnam stands at approximately 50 personnel.

SHORT DESCRIPTION: Incumbent is expected to manage the daily activities of the VFW Service Office of the Department of VIRGINIA at the Norfolk, VA Office. Provide administrative and clerical support doing claims and appeal processing to the VFW Office in Smithfield, VA and VA Regional Office, Roanoke, VA. Maintain and generate monthly National Service Office reports. Manage individual office in providing professional veterans representation for fulfillment of federal, state and local government entitlements.

WORKING CONDITIONS: Position functions in a typical office environment approximately 95% of the time. Domestic and local travel is required approximately 5% of the time to participate in conferences, outreach, Conventions and training programs, veterans' affairs hearings, staff meetings, and National Veterans Service and Department meetings, as directed. Occasional physical lifting may be required. The above duties are general in nature and may have other duties as directed by the Department Service Officer (DSO), or the Department Adjutant in the absence of the DSO.

TYPICAL DUTIES AND RESPONSIBILITIES: Each Assistant State Service Officer shall comply with all pertinent instructions and policies of the VFW National Veterans Service and VFW Virginia.

- -An Assistant State Service Officer shall maintain office hours of 8:00am to 4:00pm at the Norfolk Service Office unless otherwise directed by the Department Service Officer (DSO).
- He/She shall maintain the ability to travel as his/her duties may require for which he/she shall be reimbursed in accordance with the policies established by the DSO within the constraints of the Department budget. Such travel may include but shall not be limited to outreach services at Hampton VAMC, Norfolk Naval Station or other various military installations constrained to the geographical Tidewater, VA area, representation of the DSO at meetings of VA facility directors, VFW District meetings and training schools, VFW Post meetings and in response to special requests for speakers on VA benefits as directed by the DSO.
- -An Assistant State Service Officer shall maintain a working knowledge of all VA benefits, the forms required to apply for those benefits and the VA regulations which govern the eligibility for and payment of those benefits.

- -An Assistant State Service Officer shall assist all veterans, their dependents and their survivors in the pursuit of all federal, state or county benefits to which they may be legitimately entitled without prejudgment and without prejudice.
- -An Assistant State Service Officer shall prepare submissions of claims to appropriate agencies in a timely manner. He/she shall ensure that all claim activity is properly recorded in both the claimant's office hard copy file and in the electronic file.
- -An Assistant State Service Officer shall maintain effective communication with claimants by either letter, email or phone as may be required in a timely manner.
- -An Assistant State Service Officer shall develop and maintain good working relationships with all VFW VA representatives, all VAMC representatives, all Post and District Service Officers who assist our claimants in the preparation and development of claims.
- -An Assistant State Service Officer shall attend all training required by the Department Service Officer or by VFW National Veterans Service.
- -An Assistant State Service Officer shall maintain records of daily activities as required by the Department Service Officer and shall prepare reports as required by the DSO.
- -In addition to the above each Assistant State Service Officer shall perform all other duties as may be assigned by the Department Service Officer or Department Adjutant in the absence of the DSO.

KNOWLEDGE, SKILLS AND ABILITIEIS REQUIRED: Advanced human relations and management skills are required. This position requires knowledge of specific subjects to make the incumbent very authoritative in national veterans' affairs programs. This typically includes public speaking on a particular subject, and the incumbent may frequently be called upon for views on special veterans' issues. Thorough knowledge is required on conducting interviews, competing veterans' affairs forms and understanding Title 38 United States Code, Title 38 Code of Federal Regulations (CFR), federal court decisions and government statutes, regulations, directives and publications.

Position requires a minimum of an associate degree or three years' experience in the same or related field. It is necessary to have advanced knowledge of office equipment and particularly competes to include software applications, case management techniques and other electronic applications used in a fully automated office. Position requires VFW accreditation with the Department of Veterans Affairs, in accordance with the National Veterans Service Policy and Procedure and successful completion of the Veterans Benefits Administration (VBA) Training, Responsibility, Involvement and Preparation of claims (TRIP) test. Incumbents will, from time to time, be required to take re-certifications tests to monitor their proficiency in the laws pertaining to veterans' benefits.





They collaborate and work closely with Emory & Henry College and their equine, psychology, and therapy departments to both put the most up to date methods into practice and to train upcoming equine assisted services professionals.

Programs they have:

Healing Hooves is a therapeutic riding program serving ages 6& up with a variety of physical & mental disabilities, or cognitive delays.

Changing Strides is an at-risk youth program serving ages 6-19. They work with DSS, foster care agencies, juvenile court, and mental health agencies to provide a safe space for healing and growth. They work on personal growth, healthy relationships and communication, and self-sufficiency.

Serve a Purpose Program serves our veterans, active military, and their families with both community engagement & support, and equine assisted psychotherapy with a mental health professional.

Pony Power Reading Program is for all ages and promotes reading and literacy while being in the calm realm of horses that is judgement free.

Pony Pals Program is an all-inclusive group class that is open to ages 6-15. This group learns horse safety, handling, behaviour, communication, independence, teamwork, social skills, emotional regulation, and leadership.

Barn Buddies Program is for adults with disabilities or cognitive delays to enjoy outdoor and social activities while learning social skills, emotional regulation, and independence.

I would like to begin by thanking Department Commander Rubenstein for letting the VFW Auxiliary Virginia provide Post Commanders and members information about forming a new Auxiliary and recruiting Auxiliary members for existing Auxiliaries.

Starting a New Auxiliary

The first step to institute a new Auxiliary begins with <u>Per VFW Bylaws Section XI - no Auxiliary</u> to a Post of the Veterans of Foreign Wars of the United States shall be formed unless approved by a two—thirds (2/3) vote of the Post membership present and voting at a regular or special meeting, due notice of the proposed formation of an Auxiliary having been given the entire membership of the Post, in writing at least twenty (20) days prior to a regular meeting, or special meeting called for the aforementioned purpose. The approval to form a new Auxiliary is to be reflected in the minutes of the meeting.

Although the process to form a new Auxiliary sound like a challenge, the benefits of having an Auxiliary affiliated with your Post far outweigh the challenge. You will have a partner to work with to assist the VFW to pass or block legislation that impacts veterans and their families, provide volunteer hours in the VA Medical Centers and local medical facilities, conduct patriotic programs with thousands of students and offer hundreds of thousands of dollars in scholarships for our nation's youth. We are there to assist Veterans and their families as well as working with other organizations in our communities.

Existing Auxiliary

If your post has an Auxiliary, you already know the benefits of having an affiliated Auxiliary. If you have not already done so, you can show your support by signing up eligible family members. The best resource for new Auxiliary members (must be minimum of 16 years old), either forming a new Auxiliary (which we need fifteen new members) or an existing Auxiliary is the Post members. Included is the VFW Auxiliary Eligibility which shows the relatives to the Veteran who are eligible to become an auxiliary member. If you would like to sign up new Auxiliary members, please contact the Auxiliary President. He or she will be happy to assist you.



Learn to Recognize Signs of Veterans in Crisis

VETERANS CRISIS LINE - 988 then press (1)

Every Veteran is different, and many may not show any signs of intent to harm themselves. But some actions and behaviors can be a sign that they need help. Learn to recognize the signs of crisis so you can support a Veteran going through a difficult time.

Many Veterans don't show any signs of an urge to harm themselves before doing so. But some may show signs like these of depression, anxiety, low self-esteem, or hopelessness:

- Seeming sad, depressed, anxious, or agitated most of the time
- Sleeping either all the time or not much at all
- Not caring about what they look like or what happens to them
- Pulling away from friends, family, and society
- Losing interest in hobbies, work, school, or other things they used to care about
- Expressing feelings of excessive guilt or shame, failure, lack of purpose in life, or being trapped

They may also change the way they act, and start to show signs like these:

- Perform poorly at work or school
- Act violently or take risks (like driving fast or running red lights)
- Do things to prepare for a suicide (like giving away special personal items, making a will, or seeking access to guns or pills)
- Appearing sad or depressed most of the time
- Hopelessness
- · Anxiety, agitation, sleeplessness, or mood swings
- Feeling as if there is no reason to live
- Feeling excessive guilt, shame, or sense of failure
- Rage or anger
- Engaging in risky activities without thinking
- Increasing alcohol or drug misuse

- Losing interest in hobbies, work, or school
- Neglecting personal welfare and appearance
- Withdrawing from family and friends
- Showing violent behavior, like punching a hole in the wall or getting into fights
- Giving away prized possessions
- Getting affairs in order, tying up loose ends, or writing a will

You don't have to be an expert to talk to a Veteran facing challenges. You just need to show genuine care and concern.

My HealtheVet sign-in changes in 2025

We want to make sure you're ready for upcoming sign-in changes for VA websites and apps.

After **January 31, 2025**, you'll no longer be able to use your **My HealtheVet** user ID and password to sign in. Our records show you already have an **ID.me** account. We encourage you to start using your **ID.me** account soon so you're ready for this change.

Here's what to know:

- Don't worry. My HealtheVet isn't going away. We're just changing the way you sign
 in. We're moving to just 2 sign-in options (ID.me and Login.gov). We'll also require
 multifactor authentication (MFA) as an added layer of protection for your account.
 We're doing this to reduce the number of sign-in options Veterans need to choose
 from—and to protect all Veterans' information and benefits.
- Never give your information to anyone who says they can help you with signing in to VA websites—unless you're sure they're a VA employee or an accredited representative of VA. And always make sure a link is taking you to the official <u>va.gov</u> website before selecting it from an email, text message, social media post, or online ad. You can always go to <u>www.va.gov/sign-in-changes</u> for trusted information.
- If you need to verify your identity or add MFA for your ID.me account, we encourage
 you to do that soon. This process often takes about 10 minutes. <u>Learn more about</u>
 verifying your identity for your account
