#### 2. ACTIVE MEMBERSHIP:

The National Bylaws provide for only one type of membership: active membership. There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW Bylaws or procedures.

#### 3. BUDDY POPPIES:

State Headquarters now has Buddy Poppies (old or new) in stock. The new price for the original buddy poppies (red ones) are \$160.00 per 500. The price for the new metal poppies is \$70.00 per 500. As a reminder, poppies must be paid for before they can be shipped.

#### 4. BY-LAWS AND MANUAL OF PROCEDURE:

All officers should obtain current 2024 copies of the podium edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual. Copies of the revised edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual are available through the VFW Store at National Headquarters. The 2024 revised edition reflects the amendments adopted by the 124<sup>th</sup> National Convention, which becomes effective on August 20, 2023.

#### 5. CALENDARS:

All unsold calendars, money and calendar stubs are due by to State Headquarters by March 20, 2024.

#### 6. CLAIM SHARKS:

At the Winter Conference in Williamsburg, the State Council of Administration for the VFW Department of Virginia voted unanimously to endorse HB 736, which would make illegal in Virginia the actions of predatory Claim Sharks. These companies are known for billing veterans to file VA claims which are, and have always been, free to submit. This bill is in the **Virginia General Assembly** and is both separate and complimentary to the legislation that the VFW is pushing in Congress to do the same thing at the federal level.

Virginia's bill, which is starting in the House of Delegates, is sponsored by Delegate Briana Sewell. Delegate Sewell agreed to sponsor this bill after being approached by State Junior Vice Commander Doug Hoffman.

In the future we will send out updates on the bill. If we need constituents to call members, we will let you know and provide information to use. While we know this to be important, we will not sit back and be overconfident because it is not a win until the Governor signs the bill.

#### 9. E-MAIL ACCOUNT ACCESS:

All email accounts were reset so the new Officers could take control of their emails as of **June 13<sup>th</sup>**. This will be the primary means of sending correspondence from State Headquarters to Post and District Officers. #### 10. FRED C. HALL MEMORIAL AWARD FOR COMMUNITY SERVICE:

Each year on July 1, the national Programs office will determine the top community service Posts in each conference, based off their community service reporting and total impact, from July 1 to June 30 the previous year. Your community service total impact is figured by the money spent to host and organize the community service event, plus total hours all volunteers participated, plus the mileage for all volunteers (Dollars Donated + Hours + Mileage = Total Impact). These four Posts will be awarded the Fred C. Hall Memorial Award for Community Service and will be invited to attend the VFW National Convention. The Post Commander (or designated representative) and a guest will receive round-trip airfare, hotel accommodations for five nights, and a \$599 stipend to receive the award at the VFW National Convention.

#### OUTSTANDING COMMUNITY SERVICE POST OF THE YEAR

Each Department will have an OCSP winner based on total impact also. National will select based on end of year reports on July 1. Winners will also be published in the Convention program booklet and receive a street sign identifying this national award for the Post to put up in their community.

IRS Form 8822-B, it is now a requirement by the IRS that all Posts submit this form. This form must be submitted anytime the Post Quartermaster changes and/or the Post address changes. This is effective January 1, 2014.

#### 23. STATE SURGEON:

#### The theme for February is the heart, both for Valentine's and Heart Awareness.

Hello, Comrades and Auxiliary members of the VFW Virginia; we wish you and your family a Happy Valentine. Let's keep our hearts healthy for us and our loved ones who enjoy our company!

February is American Heart Month, a time when it is important for cardiologists and others who work with the heart to raise awareness for heart disease prevention. Patients diagnosed with cancer can be at a higher risk for, among other cardiovascular concerns, heart attack and stroke.

Cardiovascular Disease, as defined by the CDC, is a group of heart [cardio] and blood vessel [vascular] disorders that is the leading cause of death and disability -- not only in the United States but globally.

Any sustained reduction in blood flow to an organ will damage that organ. When the reduction in flow is to the heart, this causes a "<u>heart attack</u>." If the reduction is to the brain, it causes a <u>stroke</u>.

Certain chronic diseases, including hypertension and high blood cholesterol, increase the likelihood of damaging your arteries. This also increases your risk of suffering a heart attack as well as a stroke.

# **HB 736 Veterans' Services Protection Act**





#### What can be done in our state from a legislative perspective?

- Pass HB 736: The Veterans' Services Protection Act
- It updates the Virginia Consumer Protection Act
- It bans compensation for preparing claims or for referring people to banned entities.
- It protects accredited representatives and attorneys allowed to handle claims (including Virginia DVS).

#### What we think a "Claim Shark" is:

- A Claim Shark is an individual or company that charges hefty fees to "assist" or "consult" veterans with filing their VA benefit claims – this practice is illegal!
- Claim Sharks are not VA accredited, meaning they aren't required to adhere to the well-established professional and ethical standards of VA accreditation, so their advice can often be misleading or even fraudulent.
- Like a "Loan Shark," once you're in, you can't get out, and may be subject to new and • hidden fees whenever you get a new rating, no matter who does the work.

#### Some of their predatory practices are:

- Promising or guaranteeing an increased disability rating or percentage increase.
- Advertising expedited VA claims decisions.
- Requesting login credentials to access a veteran's personal information through secure VA websites like eBenefits or VA.gov.
- Using confusing tactics or ambiguous language to mislead claimants or coerce them into signing a contract.
- Telling veterans to forego VA exams and offering health consultations within their own network of doctors.





**Comprehensive.** 988 is a direct connection to compassionate care and support for anyone experiencing mental health-related distress – whether that is thoughts of suicide, mental health or substance use crisis, or any other kind of emotional distress.
