There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. 17. POSTS IN ARREARS FOR FINANCIAL OBLIGATIONS:

Attention is directed to Section 213 of the National Bylaws concerning any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in County Council and District meetings; County Council, District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

18. REPORTING:

Comrades to view whether your Post has submitted an Audit Report, Americanism, Community Service, Safety, Youth or Hospital report you should visit the Department website (<u>www.vfwva.org</u>). The website is updated daily. If you have any questions, please call State Headquarters. There will be no form for Homeless when reporting for assistance to a homeless veteran please put it on a Community Activity report under aid to others.

19. RESOLUTIONS:

"Resolutions: Resolutions are the way the rank and file of the VFW can influence the organization's priorities and processes. Program Resolutions, with the familiar WHEREAS paragraphs, are intended to bring decisionmaker attention to concerns (e.g., asking Congress to pass the PACT Act or asking the VFW National to implement a specific program). Resolutions to change By-Laws, Manual of Procedure, or Ritual take on a different format. For these proposals text to be added is <u>underlined and italicized</u> (and can even be <u>bolded</u>) whereas the text to be deleted is struck out. An example of this type of resolutions was adding Vietnam Veterans Memorial Day to the list of special days of observance in the VFW Ritual. Please see the four-page Amendments and Resolutions Manual, appended to these General Orders.

The time to submit draft Resolutions is <u>now</u>. Not only does this permit time for the Posts to work with the Resolutions Committee to smooth wording, focus logic and arguments, and identify sources of information, but it also prevents the Resolutions Committee from being overwhelmed in the week or two prior to the Department Convention, during which period, a late-submitted Resolution may not receive appropriate attention that it is due.

Posts can submit draft resolutions to the Committee prior to formal approval by Post membership so that logic and clarity of the arguments can be finessed and smoothed out. The Post can then vote on whether to approve the returned draft Resolution. Once formally approved by Post membership (at a Post meeting), the Resolution can be forwarded to State Headquarters, who will share with the Resolutions Committee. It is not necessary to submit a

Resolution to District for approval, however, best practices suggest that the Resolution be socialized in order to garner necessary support for an eventual up/down vote at Department Convention."

22. VFW DEPARTMENT SCOUTING TEAM:

The backbone of the VFW Scouting program is the VFW Scouting Team. Over the past few years, the number of members on the VFW Department Scouting Team has decreased. One of the most important functions of the Scouting Team is reviewing the nominations received for the VFW Scout of the Year in March of every year and completing the standard score sheet. The highest score determines which Scout becomes the Scout of the Year for that year.

There is one position on the Scouting Team for each of the 13 Districts in the Department to promote the values of Scouting to the youth of the community and to the VFW leadership. 23. VFW DAY OF SERVICE:

Post/District Commanders, and Comrades,

I wanted to make everyone aware of something that was brought to my attention for discussion and clarification. This is worth getting out now and re-enforced to our District Commanders and Post Commanders before May 2025 so you can plan for it.

One of the All-American Program requirements is to participate in the <u>VFW Day of Service</u>. This is how it's worded in the program book:

A Post must submit a community service report quarterly to their Department for submission to the All-American Dashboard. The quarters are July-Sept, Oct-Dec, Jan-March, and April-June. **One of these community service activities must be for the VFW Day of Service.** Learn more at: <u>https://todaysvfw.org/vfw-day-of-service/</u>

Even though it says to "submit a community service report quarterly **to their Department**", that's NOT how the VFW Day of Service is going to be recorded or tracked.

As per a conversation with Lynn Rolf, VFW Director of Programs, about what we may need to do to adjust our reporting from Virginia to handle this. He stated that Posts will be required to go to <u>https://todaysvfw.org/vfw-day-of-service/</u> and enter their event using the "Sign Up Now" button. So, not only do they need to report this directly to National, but it's reported differently than Patriot's Pen, Voice of Democracy, etc. There also will **NOT** be a way of seeing who has or hasn't reported their event on the National Dashboard. Unless something changes at National between now and then, this is how this new requirement will be handled.

The Department IT Committee Chairman Robert "Check" Adamczyk updated the All-State and All-American page on the State website to show where to report it, but the key thing is that there isn't going to be a way to track it.

Therefore, consider this message an early "<u>heads up</u>" of what to expect in May 2025. Getting this news out to District Commanders and having them make sure the Posts understand this and when they submit the report to National. State Reps. need to remind the Posts/Districts when they do their first District meeting in 2025. <u>The Day of Service is May 3, 2025</u>. Since there will be no way for Districts or Departments to see who has and who hasn't met this requirement, it's going to be even tougher to track than usual.

24. VIETNAM WAR COMMEMORATION:

The following historical events for the Vietnam War took place during February:

Feb 8, 1962 - The United States activates Military Assistance Command, Vietnam (MACV), with headquarters in Saigon. MACV's first commander is General Paul D. Harkins. The new command absorbs and supervises the Military Assistance and Advisory Group, Vietnam. From 1962 on, MACV directs the conduct of the war.

Feb 19, 1962 - The Navy establishes and begins training 13-man Seabee Technical Assistance Teams (STATs) to counter Communist insurgents through civic action programs and to support CIDGs. The first STATs deploy to Vietnam in January 1963. In South Vietnam, STATs build military installations, village fortifications, houses, schools, hospitals, roads, bridges, and wells. They also fortify isolated bases held by U.S. Special Operations forces and their paramilitary troops.

Feb 7, 1965 - Early in the morning, while it is still dark, approximately ten Viet Cong insurgents breach the fenced perimeter of the U.S. Army advisory facility near Pleiku, in the South Vietnamese Central Highlands. The infiltrators place demolition charges against several structures, detonate them, and begin throwing additional charges and mortar rounds through windows and damaged walls. The attack lasts for about ten minutes. At the same time, a few kilometers away, two five-man Viet Cong mortar teams enter the aircraft parking area of Camp Holloway, an Army helicopter base and headquarters for the 52d Aviation Battalion. Over the course of ten minutes, the Viet Cong teams fire mortar rounds and detonate charges against parked aircraft and barracks buildings. The attacks kill eight Americans and wound over 100 others. Over a dozen aircraft are destroyed or damaged. The attackers escape both the advisory base and Camp Holloway with no casualties.

Feb 8, 1965 - In the immediate wake of the Viet Cong attack at Pleiku, President Johnson reads a report submitted by National Security Advisor McGeorge Bundy regarding Bundy's recent trip to South Vietnam. Bundy's report notes that "without U.S. action defeat appears inevitable." Johnson decides to authorize the systematic bombing of North Vietnam in an attempt to prop up the Saigon regime and deter Hanoi's support for Viet Cong insurgents. Initial retaliatory bombings eventually develop into the years-long bombing operation called ROLLING THUNDER. Johnson is publicly silent about his decision to authorize the bombings.

Feb 8, 1965 - President Johnson orders airstrikes against North Vietnamese military targets. They are codenamed Operation FLAMING DART. U.S. Navy carrier aircraft strike enemy installations near Dong Hoi, North Vietnam. The next day, U.S. Air Force and South Vietnamese aircraft strike North Vietnamese barracks and antiaircraft sites near the DMZ. These are the first U.S. Air Force strikes against North Vietnam.

Feb 10-11, 1965 - Viet Cong guerrillas detonate a bomb at a U.S. Army barracks facility in the South Vietnamese coastal city of Qui Nhon. The blast kills 23 Americans and 7 South Vietnamese. In response, President Johnson orders additional air attacks in North Vietnam on February 11, known as FLAMING DART II. U.S. Navy and Air Force and South Vietnamese aircraft hit barracks and other facilities at Chanh Hoa and Vu Con with rockets and bombs.

Feb 16, 1965 - A U.S. helicopter pilot spots a 130-foot North Vietnamese trawler unloading cargo on a remote beach in South Vietnam's Vung Ro Bay. Airstrikes capsize the trawler. Three days later, allied personnel reach the scene and find that the trawler was carrying about 100 tons of arms, ammunition, explosives, and other supplies intended for the Viet Cong. The incident helps provide the final justification for Operation MARKET TIME. This combined U.S. Navy-U.S. Coast Guard-South Vietnamese navy coastal patrol operation is designed to stem the flow of smuggled supplies by sea from North to South Vietnam. During the next seven years, the patrol vessels and aircraft of MARKET TIME help thwart the great majority of infiltration by North Vietnamese coastal vessels. The North Vietnamese respond by moving their seaborne smuggling operations further south, through the ostensibly neutral port at Sihanoukville, Cambodia. They also increase the volume of traffic moving overland through Laos and Cambodia via the Ho Chi Minh Trail.

Feb 25, 1965 - The Republic of Korea Military Assistance Group, Vietnam, also known as Dove Unit, begins to arrive in Vietnam. It is based in Bien Hoa Province. South Korea's Dove Unit includes a noncombat force of about 2,400 men comprising a construction support group, marine corps engineer company, army security company, and navy amphibious unit.

Feb 26, 1965 - President Johnson's decision to use American airpower to bomb North Vietnam leads him to further conclude that the United States requires more ground forces in South Vietnam, whose responsibility it will be to protect growing U.S. air bases and other facilities from retaliation by Communist troops. Johnson approves General William Westmoreland's request for two Marine Corps battalions to fill this role, and the Marines begin preparations for a landing at Da Nang, in northern South Vietnam.

Feb 17, 1966 - Thailand activates the Royal Thai Military Assistance Group, Vietnam. The Royal Thai Air Force contingent already in South Vietnam comes under the new group's command. The Thai forces in South Vietnam eventually consist of Royal Thai Air Force, Navy, and Army groups. The largest contingent is from the Army. Later in the year MACV places them under the operational control of the 9th U.S. Infantry Division.

Feb 14-15, 1967 - The 11th Company of the Republic of Korea 2d Marine (Blue Dragon) Brigade is surrounded and attacked by a regiment-sized force of Viet Cong and North Vietnamese troops near a village southwest of Chu Lai. The attackers breach the Koreans' perimeter with bangalore torpedoes and flame throwers. Some Korean troops are forced to resort to hand-to-hand combat. A South Korean counterattack ultimately drives off the larger enemy force.

Feb 22, 1967 - Elements from multiple U.S. Army, U.S. Air Force, and South Vietnamese army units take part in Operation JUNCTION CITY. The operation is the primary offensive of the overall campaign in III Corps and its objective is to encircle and destroy the Viet Cong 9th Division, which controls the area northwest of Saigon near the Cambodian border. JUNCTION CITY represents one of the largest helicopter actions of the war, and the offensive begins with the only major parachute assault of the war. The operation lasts until May. U.S. troops capture 850 tons of food and about 500,000 pages of documents, kill over 2,700 enemy soldiers, and force Viet Cong commanders to move their southern headquarters into Cambodia.

Feb 24, 1968 - As part of the assaults on Khe Sanh and Hue, enemy forces begin attacking allied shipping on the Cua Viet and Perfume Rivers. These waterways are crucial supply and communication links for northern I Corps. Deputy Commander of MACV, General Creighton Abrams, requests Naval Forces Vietnam to create a task force that can protect supply convoys and keep waterways open to traffic. It is known as Task Force Clearwater.

Task Force Clearwater begins escorting river supply convoys with patrol boats, helicopter gunships, and ground troops, which act as reaction forces during ambushes. The task force proves especially vital for protecting supplies intended for the besieged Marine garrison at Khe Sanh.

Feb 27, 1968 - After his trip to Vietnam in early 1968, anchorman Walter Cronkite broadcasts his coverage of the Tet Offensive. Cronkite concludes his report with a personal commentary, voicing his skepticism of official assertions of military progress.

"To say that we are closer to victory today is to believe, in the face of evidence, the optimists who have been wrong in the past. To suggest we are on the edge of defeat is to yield to unreasonable pessimism. To say that we are mired in stalemate seems the only realistic, yet unsatisfactory, conclusion. . . . But it is increasingly clear to this reporter that the only rational way out then will be to negotiate, not as victors, but as an honorable people who lived up to their pledge to defend democracy, and did the best they could." –Walter Cronkite

February 1968 - As the Tet Offensive rages, U.S. Air Force aeromedical evacuation aircraft transport more than 10,000 wounded and injured personnel during February alone. Air Force Airlift units average over 9,000 patients evacuated per month through the month of June.

Feb 23, 1969 - The North Vietnamese and Viet Cong launch artillery attacks on over 100 population centers and military targets across South Vietnam. The attacks represent a Communist attempt to mount another sustained

offensive close to the Tet season, though this one is far weaker than Tet 1968. Communist forces target Saigon and other cities and installations with mortar and rocket fire. MACV commander General Abrams quickly orders a fourday retaliatory bombardment of North Vietnam below the 19th parallel using both air strikes and naval artillery. In March, President Nixon orders further retaliatory air strikes known as Operation MENU. The erratic Communist offensive lasts until June.

Feb 8, 1971 - Approximately 17,000 South Vietnamese soldiers and marines launch Operation LAM SON 719, along Highway 9 into Laos. Their objective is to interdict enemy supply efforts on the Ho Chi Minh Trail, west of Khe Sanh. Although the South Vietnamese are supported by U.S. Army helicopters and U.S. Air Force aircraft, American ground forces are not permitted to enter Laos. The operation is an important test of the progress of Vietnamization. A much larger North Vietnamese force stalls and then reverses the assault, and the South Vietnamese suffer high casualties. LAM SON 719 ends on March 24.

Feb 12, 1973 - A U.S. Air Force C-141, the "Hanoi Taxi," airlifts the first American prisoners of war to freedom from Gia Lam Airport in Hanoi, North Vietnam. From February 12 to March 29, U.S. transport aircraft fly POWs home from Southeast Asia as part of Operation HOMECOMING. In all, 591 American military and civilian prisoners are released, including individuals held by North Vietnam, the Viet Cong, the Pathet Lao, and the People's Republic of China.

PREPARING A PROPOSED AMENDMENT TO THE NATIONAL BYLAWS, MANUAL OF PROCEDURE OR RITUAL

Bylaws: Any member in good standing, a Post, a District, or a Department, may propose an amendment to the National Bylaws; provided, however, before consideration at the National Convention, the proposed amendment must be approved by a Department Convention. Immediately following a Department Convention, the proposed amendment(s) must be forwarded to National Headquarters.

Manual of Procedure and Ritual: Any Post, District, or Department may propose an amendment to the Manual of Procedure or Ritual; provided, however, before consideration at the National Convention, the proposed amendment must have been forwarded, through channels and have been properly approved.

In order to meet National Bylaw/Manual of Procedure Article XIV requirements, to provide fifteen (15) day notice to all Posts of all amendments, the Adjutant General requests all amendments be forwarded to National Headquarters no later than five (5) working days following the close of the Department Convention.

Bylaw, Manual of Procedure or Ritual changes not in proper form, unclear as to meaning, or concerning matters clearly not within the scope and purpose of the Veterans of Foreign Wars cannot be considered by the National Convention.

A proposed change to the National Bylaws, Manual of Procedure or Ritual must be submitted as such, not as a resolution. Proposed amendments must be definite and specific as to the verbiage to be deleted or added. Use of the most recent amended copy of the National Bylaws, Manual of Procedure and Ritual is encouraged, as proposed changes considered by Convention delegates cannot be amended on the floor.

EXAMPLE 1

Proposed Amendment to National Bylaws proposed by Department of . Section 202 – Bylaws.

Amend Section 202, National Bylaws, by deleting the words "two-thirds (2/3)" in the first sentence of paragraph one, and inserting, in lieu thereof, the following: "majority".

EXAMPLE 2

Proposed Amendment to National Manual of Procedure proposed by Department of Section 518 – Officers: Duties and Obligations.

Amend Section 518, Manual of Procedure, by deleting paragraph (a) (1) d. in its entirety and inserting, in lieu thereof, the following:

"Plan and organize all social functions."

EXAMPLE 3

Proposed Amendment to National Ritual proposed by Department of ______. Amend the Ritual by deleting on page 48, in the last sentence of the Member's Obligation, the words "and a citizen of our great republic."

Further amend by placing a period after the word "comrade" in the same sentence.

If you require help composing a proposed change to the Bylaws, Manual of Procedure or Ritual, please contact Administrative Operations at National Headquarters for advice and assistance in properly preparing a proposed amendment to be voted upon by your department convention.

PREPARING A RESOLUTION TO BE CONSIDERED BY THE NATIONAL CONVENTION

The policy of the Veterans of Foreign Wars is established by resolutions adopted by the delegates attending Department and National Conventions. Most resolutions originate at the Post level and are passed through the District and Department before being acted upon at a National Convention. Many times, an otherwise worthy idea gets nowhere merely because it is not correctly presented.

A resolution contains two separate parts; a statement of the problem to be solved, and the proposed solution to the problem. The problem is outlined in the "*WHEREAS*" clauses, and the proposed solution is given in the "*RESOLVED*" section.

The "*RESOLVED*" section of a resolution should be complete in itself without depending on the "*WHEREAS*" clauses to give it meaning.

EXAMPLE

WHEREAS, the rising cost of living has created an intense hardship on those disabled veterans whose only income is a meager pension check; now, therefore

BE IT RESOLVED, that we petition Congress to enact legislation which would provide a substantial increase in non-service connected pension rates.

If a resolution deals with a local problem, it needs no action on a level higher than that of the Post. If the problem concerns an area larger than that served by the Post, it should, after Post approval, be presented before the District or County Council. All resolutions of statewide, regional or national concern must be acted upon by the Department Convention. Those resolutions approved by a Department Convention, which affect persons or matters <u>outside</u> the state boundaries, must be forwarded to the National Convention for final disposition.

When submitting a resolution to the Department Convention, a notation on the bottom should show the previous action taken, such as, approval by Post and, if applicable, by the District. A Post or District submitting a resolution to its Department Convention must follow guidelines established by the Department, which may require submitting the resolution to the Department Adjutant prior to the convening of the convention.

Resolutions not in proper form, with unclear meaning, or concerning matters clearly not within the scope and purpose of the Veterans of Foreign Wars <u>cannot</u> be considered by the National Convention.

Resolutions approved by a Department Convention, which affect matters outside state boundaries, must be forwarded by the Department Adjutant to the National Convention for final disposition. Approved resolutions should be sent to National Headquarters at the close of the Department Convention. The Adjutant General requests all resolutions be forwarded to National Headquarters no later than five (5) working days following the close of the Department Convention. A resolution disapproved by the Department Convention or not acted upon by the Department Convention will not be considered by the National Convention.

Resolutions may also be originated by Department officers or by the Department Convention itself and acted upon by the Department Convention. A National Officer may originate a resolution concerning National affairs and submit it directly to the National Convention without Department action. Likewise, a National Convention Committee may originate a resolution and present it for approval during the National Convention. *Policy set by the National Convention is binding upon all subordinate units of the Veterans of Foreign Wars. No Post or Department is permitted to take any individual action or espouse any cause contrary to the National Bylaws or to the actions of the National Convention as outlined herein.*










They are a 501c3 non-profit, they are a self-sustaining organization that relies on fundraising, donations, and grants to pay staff, care for their horse partners, monthly rent for their facilities, and all other expenses. They do work with Blue Mountain Therapy to provide quality services with their amazing staff. Their services are not billable to insurance companies currently. They are part of an army of equine assisted service providers working hard to supply hard data and results that will push companies to recognize the benefits and pay for these services. This is why they Fundraise so much! Their staff, board members, and volunteers work hard on raising funds all year to help cover the cost of services and care for their horse partners. They ask for no more than 1/3 of the cost of providing an equine assisted service from the family they serve. They have a sliding scale that can take the cost down to as low as \$5 per session. So fundraising and your support makes it possible to provide a trained & healthy equine partner, an equine specialist &/or certified therapeutic riding instructor, a therapist or counsellor in some cases, volunteers or added staff for aid, and the equipment and facility to those benefiting from our programs in your community. They work closely with Physical, occupational, and speech therapists, as well as, behaviour technicians, mental health professionals, and social workers from Blue Mountain Therapy. They collaborate and work closely with Emory & Henry College and their equine, psychology, and therapy departments to both put the most up to date methods into practice and to train upcoming equine assisted services professionals.

Programs they have:

Healing Hooves is a therapeutic riding program serving ages 6& up with a variety of physical & mental disabilities, or cognitive delays.

Changing Strides is an at-risk youth program serving ages 6-19. They work with DSS, foster care agencies, juvenile court, and mental health agencies to provide a safe space for healing and growth. They work on personal growth, healthy relationships and communication, and self-sufficiency.

Serve a Purpose Program serves our veterans, active military, and their families with both community engagement & support, and equine assisted psychotherapy with a mental health professional.

Pony Power Reading Program is for all ages and promotes reading and literacy while being in the calm realm of horses that is judgement free.

Pony Pals Program is an all-inclusive group class that is open to ages 6-15. This group learns horse safety, handling, behaviour, communication, independence, teamwork, social skills, emotional regulation, and leadership.

Barn Buddies Program is for adults with disabilities or cognitive delays to enjoy outdoor and social activities while learning social skills, emotional regulation, and independence.

I would like to begin by thanking Department Commander Rubenstein for letting the VFW Auxiliary Virginia provide Post Commanders and members information about forming a new Auxiliary and recruiting Auxiliary members for existing Auxiliaries.

Starting a New Auxiliary

The first step to institute a new Auxiliary begins with <u>Per VFW Bylaws Section XI -</u> no Auxiliary to a Post of the Veterans of Foreign Wars of the United States shall be formed unless approved by a two-thirds (2/3) vote of the Post membership present and voting at a regular or special meeting, due notice of the proposed formation of an Auxiliary having been given the entire membership of the Post, in writing at least twenty (20) days prior to a regular meeting, or special meeting called for the aforementioned purpose. The approval to form a new Auxiliary is to be reflected in the minutes of the meeting.

Although the process to form a new Auxiliary sound like a challenge, the benefits of having an Auxiliary affiliated with your Post far outweigh the challenge. You will have a partner to work with to assist the VFW to pass or block legislation that impacts veterans and their families, provide volunteer hours in the VA Medical Centers and local medical facilities, conduct patriotic programs with thousands of students and offer hundreds of thousands of dollars in scholarships for our nation's youth. We are there to assist Veterans and their families as well as working with other organizations in our communities.

Existing Auxiliary

If your post has an Auxiliary, you already know the benefits of having an affiliated Auxiliary. If you have not already done so, you can show your support by signing up eligible family members. The best resource for new Auxiliary members (must be minimum of 16 years old), either forming a new Auxiliary (which we need fifteen new members) or an existing Auxiliary is the Post members. Included is the VFW Auxiliary Eligibility which shows the relatives to the Veteran who are eligible to become an auxiliary member. If you would like to sign up new Auxiliary members, please contact the Auxiliary President. He or she will be happy to assist you.


