#### 2. ACTIVE MEMBERSHIP:

The National Bylaws provide for only one type of membership: active membership. There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW Bylaws or procedures.

#### **3. AUDIT REPORTS:**

Attention of Post Commanders is directed to Section 218 (a)(11) of the National Manual of Procedure, Officers: Duties and Obligations. Trustees Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ends March 31.

#### 4. AWARDS:

#### **MEMBERSHIP PLAQUES**

Membership plaques will be presented at the State Convention to the Post with the largest numeric membership increase in each category. The judging will be based on Membership as of **Friday**, **May 9**, **2025**.

- Category A Posts with Membership of 10 thru 75
- Category B Posts with Membership of 76 thru 150
- Category C Posts with Membership of 151 thru 250
- Category D Posts with Membership of 251 thru 500
- **Category E** Posts with Membership of **501 or more**

#### LIFE MEMBERSHIP INCREASE AWARD

A Life Membership increase award and \$200.00 will be awarded at the State Convention to the Post with the greatest increase in Life members (must be at least 3 new Life members) in each category. The judging will be based on Life Membership as of **Friday**, **May 9**, **2025**.

Category A – Posts with Membership of 10 thru 75

- Category B Posts with Membership of 76 thru 150
- Category C Posts with Membership of 151 thru 250

Category D – Posts with Membership of 251 thru 500 Category E – Posts with Membership of 501 or more

#### 2024-2025 POST ALL-STATE REQUIREMENTS Note: There is no limit on the number of Posts that can be All-State.

1. The Post must meet their 101% Membership Quota by May 9, 2025, and recruit Three (3) New members, to be recognized. Achieving 101% after May 9, 2025, will be recognized at the next District Meeting (NO Exceptions).

2. All Post personnel with access to the assets must be bonded.

3. The Post must have been inspected and the Inspection Reports must be received by State Headquarters no later than **4:00pm on December 13, 2024**, also with all documented discrepancies corrected by **Friday, May 9, 2025**, to complete this requirement.

4. The Post Commander, Quartermaster, and Adjutant must sign into the department email and send one (1) email to either <u>cdr@vfwva.org</u> or <u>mrubenstein@vfwva.org</u> no later than **October 1, 2024**. It is each Post Commander, Quartermaster, and Adjutant's responsibility to ensure this is met and it will be visible in the Online Reports.

5. A minimum of **any**, **one** (1) **of all Post officers** must attend each District Meeting and it is highly recommended that every Post officer attending bring at least one (1) up-and-coming member who demonstrates the ability, enthusiasm, and qualities, to be a future officer in your post. <u>We need to Mentor our officers of the future</u>. **Note:** In the past we have required at least one of the top 5 Post officers to attend District Meetings. That is not a requirement this year as stated above.

6. The Post Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster or Adjutant must attend the **School of Instruction (SOI)**, this is for your benefit as a learning experience.

7. The Post must send **a Post Member** to the **State Recruiting School of Instruction (RSOI)** (preferably a member from the post membership/recruiting team) that should be listed on your Membership Plan.

8. **All Quarterly Audit Reports** must be turned into State Headquarters as required by Section 218 of the National By-Laws and Manual of Procedure. Posts may not have more than one late report out of the four required.

9. The Post must purchase **500 Buddy Poppies per 100 members** or fraction thereof.

10. The Post must donate to the Department Virginia Veterans Foundation (VVF) Posts with:

99 members or less - \$150.00 – For every \$150 above the donation will earn (1) Team Point

100 to 399 members - \$300.00 - For every \$300 above the donation will earn (1) Team Point

400 or more members - \$400.00 - For every \$400 above the donation will earn (1) Team Point

11. The Post must have submitted the following reports at least once a quarter by Sept 30, 2024, Dec 31, 2024,

Mar 31, 2025, and June 30, 2025.

12. The Post must participate in at least 2 of the 4 following programs:

Patriot's Pen Program (must submit a student to the district level for district judging).

Voice of Democracy Program (must submit a student to the district level for district judging).

JROTC, Sea Cadets, and Civil Air Patrol (must submit a student to the district level for district judging).

Teacher of the Year Program (Post must submit at least one Teacher to the district level for district judging).

13. The Post must reach 101% on Memstats by June 30, 2025.

**Note 1**: Five (5) additional points towards the Captain of the All-State Team will be awarded to Posts submitting entries in all four (4) programs.

**Note 2**: Five (5) additional points for each of the submission of an entry for EMT, EOD Technician, Fireman, Law Enforcement, 911 Dispatcher, and/or Scout of the Year.

**Note 3**: Posts will receive additional points towards the Captain of the All-State Team for membership. One fifth (1/5) of one (1) point will be assigned for each additional member above 101%. **Note 4**: Posts with less than 50 members are now eligible for the All-State Team.

#### POST ALL STATE TEAM AWARDS

1. All-State Post Commanders who have met all the criteria, including membership, by **Friday, May 9, 2025** (and have not received an All-State cap for this level of leadership since June 2019) will receive an All-State cap, an All-State pin and citation during the State Convention. Additionally, a check in the amount of \$300.00, to assist in payment of expenses while attending and participating at the State Convention will be presented to those Post Commanders who achieve the All-State award by **Friday, May 9, 2025**, and attend all required events at the State Convention. Time of payment will be at the discretion of the Department Commander. All-State Commanders meeting the criteria except for membership by **Friday, May 9, 2025**, and then meet the membership criteria by **Monday, June 30, 2025**, will receive a citation and an All-State pin at their next District meeting but will not receive any monetary award nor a cap.

2.All-State Post Quartermasters who have met all the criteria, including 101% membership, by **Friday, May 9**, **2025** (and have not received an All-State cap for this level of leadership since June 2019) will receive an All-State cap, an All-State pin and citation during the State Convention. Additionally, a check in the amount of \$300.00, to assist in payment of expenses while attending and participating at the State Convention will be presented to those Post Quartermasters who achieve the All-State award by **Friday, May 9**, **2025**, and attend all required events at the State Convention. Time of payment will be at the discretion of the Department Commander.

3.All-State Quartermasters meeting the criteria except for membership by **Friday**, **May 9**, **2025**, and then meeting the membership criteria by **Monday**, **June 30**, **2025**, will receive a citation and an All-State pin at their next District meeting but will not receive any monetary award nor a cap.

4. From the All-State Team, the Post with the highest points in the All-State judging on **Friday**, **May 9**, **2025**, will be designated as the Outstanding Post of the Year 2024-2025. The Commander and Quartermaster of that Post will be the Captains of the All-State Team.

5. The Awards and Citation Committee will break all ties and their decision will be considered the recommendation to the State Commander.

6. The State Commander shall make the final decision for all recommendations of awards and the decision shall be final.

#### 2024-2025 DISTRICT ALL STATE REQUIREMENTS \*\*There is no limit on the number of Districts that can be All-State\*\*

1. The District must meet their 101% Membership Quota by Sunday, June 29, 2025.

2. All Posts in the District and the District must be inspected; State Headquarters must receive the <u>Inspection</u> <u>Reports</u> no later than Monday, December 16, 2024, with all <u>documented discrepancies</u> corrected by Friday, May 9, 2025, to complete this requirement.

3. The District Quartermaster and anyone else with access to money must be properly bonded.

4. The District Commander, Sr Vice Commander, Quartermaster, and Adjutant must sign into the dept. email and send one (1) email to either <u>cdr@vfwva.org</u> or <u>mrubenstein@vfwva.org</u> no later than **October 1, 2024** and will ensure that it is listed as done in the Online Reports.

5.All Audit Reports for the District must be turned into State Headquarters as required by the National By-Laws and Manual of Procedure.

6. All Posts in the District must have submitted the following reports at least once a quarter by Sept 30, 2024, Dec 31, 2024, Mar 31, 2025, and June 30, 2025.

7. The District must conduct a District School of Instruction (SOI) by the end of Sunday, October 6, 2024.

Department led School of Instruction meets the requirement of the terms stated above.

8. The District must donate \$100.00 to the Department's Virginia Veterans Foundation (VVF).

#### All-State District Awards

1.All-State District Commanders who have met all the criteria including membership by **Friday**, **May 9**, **2025** (and have not received an All-State cap for this level of leadership since June 2020) will receive an All-State District Commander's cap, an All-State pin and an All-State Citation during the State Convention. All-State Commanders meeting the criteria, **except for membership**, **by Friday**, **May 9**, **2025**, and **then meet the membership criteria by Monday**, **June 30**, **2025**, will receive an All-State pin and Citation at their next District meeting but will not receive an All-State cap.

2.All-State District Commanders will receive a VFW Vest if **all Posts within their District are 101%** or more in membership by **Friday**, **May 9**, **2025**.

#### INDIVIDUAL MEMBERSHIP AWARDS

Be advised that as per the National Commander in Chief any lapsed member (regardless of length of time their dues are lapsed) will be counted as a Continuous member (Annual or Life) - <u>Recruiter credit will only be given</u> for Brand New Members to the VFW.

1.All individual recruiting awards will be awarded by using the National Recruiter Reports dated **Friday**, **May 9, 2025**. These awards will be presented at the State Convention.

#### 2. Annual members recruiting Three (3) New Members will receive:

- a. Their Annual Dues (National and Department portions) paid by the Department for the current year.
- b. Their name and membership number will be entered in a drawing for a Life Membership.

c. For each <u>additional Three (3) members</u> recruited, an additional entry will be made in the Life Membership Drawing.

d. The drawing for the Life Membership listed above will be conducted on the day of awards judging.

#### 3.Life Members recruiting three (3) New Members will receive:

a. Name and membership number will be entered in a drawing for one level of Legacy Life membership equal to \$400.00 or if already a gold member, may transfer the award to another post member or receive a check for \$200.00.

b. For each **additional three (3) members recruited**, an additional entry will be made in the drawing. c.The drawing for the Legacy Life Membership award listed above will be conducted on the day of awards judging **Friday**, **May 9**, **2025**.

#### THE GEORGE E. McCRACKEN HONOR GUARD/COLOR GUARD AWARD

The George E. McCracken Honor Guard/Color Guard Award is presented to the most outstanding Post Honor Guard/Color Guard. **Deadline for submission** to State Headquarters is by the day prior to awards judging **Friday**, **May 9, 2025**. This award will be **presented at the State Convention**, **June 2025**.

#### THE W. I. WOODDELL MEMORIAL POST QUARTERMASTER AWARD

The W. I. Woodall Memorial Post Quartermaster Award is presented to the Post Quartermaster who has shown outstanding dedication to his Post and the Department. The Post Commander must send in a nominating letter on why the Post Quartermaster should be considered for Quartermaster of the year. Submission must be received the day prior to the awards judging **Friday**, **May 9**, **2025**. The recipient is to be selected by a committee headed by the State Quartermaster. The award will consist of a custom lettered citation, plus a check in the amount of \$200.00 from the Department. This award will be presented at the **State Convention**, **June 2025**.

#### SCOUT OF THE YEAR AWARD

The Scout of the Year Award is presented to the State Scout of the Year winner. A plaque and a \$500.00 monetary award will be presented. This award will be **presented at the State Convention, June 2025**. An additional (5) five points will be earned for the submission of an entry for Scout of the Year.

#### THE CHRIS MULHOLLAND COMMUNITY SERVICE RECORD BOOK

The Chris Mulholland Community Service Record Book should be kept from May 1, 2024, to April 30, 2025, for State judging. Plaques will be awarded to the top three (3) entries at the State Convention, June 2025. Special Citations will be awarded to the fourth through tenth places. Electronic submissions will be accepted this year. Electronic entries must be submitted on a thumb drive. The Chris Mulholland Community Service Record Book is not a requirement to be All-State.

#### 5. BY-LAWS AND MANUAL OF PROCEDURE:

All officers should obtain current 2025 copies of the podium edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual. Copies of the revised edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual are available through the VFW Store at National Headquarters. The 2025 revised edition reflects the amendments adopted by the 125th National Convention, which became effective on Aug. 28, 2024.

#### 6. CLAIM SHARKS:

Over the last two years, we engaged in a legislative effort to ban Claim Sharks from Virginia as they bill veterans for a VA claim act in violation of federal regulations. Our effort was to protect the hundreds of thousands of veterans and their families here in the Commonwealth. Our cause is noble and equal to the other great legislative battles that the VFW is known for and what our members expect from us as an advocacy group.

Our bill to ban these companies in Virginia was unsuccessful this year, but we should not be upset about that. We should be proud to know that we stopped the bill to allow these companies to charge. It is sad that so many Claim Sharks are veterans. They should be helping, not hurting, their fellow veterans. Part of legislative advocacy is that sometimes you work to get good bills passed and sometimes you work to kill bad bills. We did both this year.

I am so proud of the VFW and I thank you for all that you did to help. You wrote letters, spoke in hearings, made phone calls, and showed presence in the room. One can say that Claim Sharks hurt veterans, but you showed it as being a reality and not some hypothetical issue conjured by lobbyists. You showed that average veterans do matter more than company profits and you made those companies spend ungodly amounts of money to stop us. While our bill did not pass, we inflicted pain and showed the world how devious these companies are in their words and deeds.

I want to again express the VFW's undying gratitude for Delegate Brianna Sewell. She has been our champion for this cause and her efforts continue her history of advocacy for veterans and consumers. The daughter of two veterans, Delegate Sewell poured everything she had into this and took on powerful members of the General Assembly and well-funded special interests. Delegate Sewell is an amazing and is all we should hope for in our elected officials

Thank you and let us never stop or be ashamed of our noble efforts.

#### 8. DISTRICT CONVENTIONS:

Section 222 of the National Bylaws and the Manual of Procedure provides that delegates and alternates for the District Convention and meetings, Department and National Conventions shall be elected at a regular meeting in April. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post as of March 31.

Pursuant to Section 403 of the National Bylaws and the Manual of Procedure, each District shall hold an annual District Convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention.

Pursuant to Section 403 of the National Bylaws – Regular Meeting, Districts shall hold at least two (2) regular meetings each year for purposes of transacting business and conducting schools of instruction.

Pursuant to Section 417 of the National Manual of Procedure, District officers shall not assume the duties of their office until the Department Commander is installed.

District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

The 126th National Convention housing will officially open March 18, 2025. Housing reservation information will be located on the convention website accessed through the main VFW website at vfw.org/convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee provided the Post has paid the mandated \$25 advance registration fee. All advance registrations should be mailed to the VFW National Headquarters, 406 W. 34th Street, Kansas City, MO 64111. **ATTN:** Convention Registration, Quartermasters are strongly encouraged to register delegates utilizing the on-line membership system (OMS).

Attention is directed to Section 217 of the National Bylaws and the Manual of Procedure covering the nomination, election and installation of Post Officers. Post Election Report forms are being mailed to Post Quartermasters with instructions that they complete the form online through the Online Membership System (OMS) or they can complete the form and return directly to National Headquarters immediately following the election of Post Officers but not later than June 1.

#### 20. POSTS IN ARREARS FOR FINANCIAL OBLIGATIONS:

Attention is directed to Section 213 of the National Bylaws concerning any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly

completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in County Council and District meetings; County Council, District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

#### 21. **REPORTING:**

Comrades to view whether your Post has submitted an Audit Report, Americanism, Community Service, Safety, Youth or Hospital report you should visit the Department website (<u>www.vfwva.org</u>). The website is updated daily. If you have any questions, please call State Headquarters. There will be no form for Homeless when reporting for assistance to a homeless veteran please put it on a Community Activity report under aid to others.

#### 22. **RESOLUTIONS:**

"Resolutions: Resolutions are the way the rank and file of the VFW can influence the organization's priorities and processes. Program Resolutions, with the familiar WHEREAS paragraphs, are intended to bring decisionmaker attention to concerns (e.g., asking Congress to pass the PACT Act or asking the VFW National to implement a specific program). Resolutions to change By-Laws, Manual of Procedure, or Ritual take on a different format. For these proposals text to be added is <u>underlined and italicized</u> (and can even be <u>bolded</u>) whereas the text to be deleted is <u>struck out</u>. An example of this type of resolutions was adding Vietnam Veterans Memorial Day to the list of special days of observance in the VFW Ritual. Please see the four-page Amendments and Resolutions Manual, appended to these General Orders.

The time to submit draft Resolutions is <u>now</u>. Not only does this permit time for the Posts to work with the Resolutions Committee to smooth wording, focus logic and arguments, and identify sources of information, but it also prevents the Resolutions Committee from being overwhelmed in the week or two prior to the Department Convention, during which period, a late-submitted Resolution may not receive appropriate attention that it is due.

Posts can submit draft resolutions to the Committee prior to formal approval by Post membership so that logic and clarity of the arguments can be finessed and smoothed out. The Post can then vote on whether to approve the returned draft Resolution. Once formally approved by Post membership (at a Post meeting), the Resolution can be forwarded to State Headquarters, who will share with the Resolutions Committee. It is not necessary to submit a

Resolution to District for approval, however, best practices suggest that the Resolution be socialized in order to garner necessary support for an eventual up/down vote at Department Convention."

The highest score determines which Scout becomes the Scout of the Year for that year.

#### 27. VFW DAY OF SERVICE:

Post/District Commanders, and Comrades,

I wanted to make everyone aware of something that was brought to my attention for discussion and clarification. This is worth getting out now and re-enforced to our District Commanders and Post Commanders before May 2025 so you can plan for it.

One of the All-American Program requirements is to participate in the <u>VFW Day of Service</u>. This is how it's worded in the program book:

A Post must submit a community service report quarterly to their Department for submission to the All-American Dashboard. The quarters are July-Sept, Oct-Dec, Jan-March, and April-June. **One of these community service activities must be for the VFW Day of Service.** Learn more at: <u>https://todaysvfw.org/vfw-day-of-service/</u>

Even though it says to "submit a community service report quarterly **to their Department**", that's NOT how the VFW Day of Service is going to be recorded or tracked.

As per a conversation with Lynn Rolf, VFW Director of Programs, about what we may need to do to adjust our reporting from Virginia to handle this. He stated that Posts will be required to go to <u>https://todaysvfw.org/vfw-day-of-service/</u> and enter their event using the "Sign Up Now" button. So, not only do they need to report this directly to National, but it's reported differently than Patriot's Pen, Voice of Democracy, etc. There also will **NOT** be a way of seeing who has or hasn't reported their event on the National Dashboard. Unless something changes at National between now and then, this is how this new requirement will be handled.

The Department IT Committee Chairman Robert "Check" Adamczyk updated the All-State and All-American page on the State website to show where to report it, but the key thing is that there isn't going to be a way to track it.

Therefore, consider this message an early "**heads up**" of what to expect in May 2025. Getting this news out to District Commanders and having them make sure the Posts understand this and when they submit the report to National. State Reps. need to remind the Posts/Districts when they do their first District meeting in 2025. <u>The Day of Service starts May 3, 2025</u>. Since there will be no way for Districts or Departments to see who has and who hasn't met this requirement, it's going to be even tougher to track than usual.

#### 28. VIETNAM WAR COMMEMORATION:

Remember that March 29<sup>th</sup> is National Vietnam War Veterans Day and is one of the dates that all Posts should commemorate as per page 3 of the VFW Ritual.

The following historical events for the Vietnam War took place during March:

March 23, 1961 - Seven of the eight U.S. crewmen aboard a C-47 aircraft are killed when the Pathet Lao—Laotian Communist insurgents allied with North Vietnam— shoot them down over the Plain of Jars using antiaircraft artillery. Army Major Lawrence R. Bailey survives and is subsequently captured, becoming the first American prisoner of war in Southeast Asia since the end of World War II. Bailey is held and interrogated for 17 months. He is released in August 1962, and President John F. Kennedy presents him with the Bronze Star.

March 10, 1962 - Members of Navy Sea-Air-Land (SEAL) Team 1 arrive in Saigon to begin training South Vietnamese naval commandos in covert maritime operations. Established only two months earlier, in January 1962, the SEALs are the Navy's experts in special warfare—sabotage, demolition, and other clandestine activities conducted in enemy areas and from restricted seas and waterways.

March 26, 1964 - Viet Cong small arms fire downs a U.S. Air Force observation plane carrying pilot Captain Richard L. Whitesides and U.S. Army Special Forces Captain Floyd J. Thompson near the DMZ. Whitesides is never found and presumed killed. Thompson is severely wounded and eventually captured. Thompson is not released until nine years later on March 16, 1973, becoming the longest held American POW in U.S. history.

March 8, 1965 - U.S. Marines of the 9th Marine Expeditionary Brigade (MEB) arrive at Da Nang, South Vietnam. The brigade consists of two Marine battalions. One makes an amphibious landing and the other arrives by air. The 9th MEB assumes command of the helicopters of SHUFLY, which becomes Marine Aircraft Group 16.

This is the first deployment of a major U.S. ground combat unit to Vietnam. Although the mission of the 9th MEB is strictly limited to the defense of the air base at Da Nang, it signals another step in the United States' transition from an advisory role to direct participation in the war.

March 1 - 31, 1966 - The remainder of the U.S. Army 25th Infantry Division deploys to South Vietnam, establishing its headquarters at Cu Chi, northwest of Saigon. The 25th's 2d and 3d Brigades, which arrived months earlier, are joined by the rest of the division. The 25th's first major offensive begins at the end of the month. Additionally, the division's commander, General Frederick C. Weyand, is an active proponent of pacification, sometimes known as "the other war" for "hearts and minds." In line with the Johnson administration's renewed emphasis on pacification decided at the Honolulu Conference, Weyand's division carries out both pacification and offensive search-and-destroy operations. March 4, 1966 - In Operation UTAH between March 4 and 7, units of the U.S. 3d Marine Division and the South Vietnamese 2d Division defeat elements of the 21st North Vietnamese Regiment south of Chu Lai. It is the first engagement between U.S. Marines and the North Vietnamese regular military, illustrating the growing presence of North Vietnamese regular troops operating within the borders of South Vietnam.

March 18, 1967 - Marine Master Sergeant Barbara J. Dulinsky arrives in Saigon. She is the first woman Marine to serve in Vietnam. Dulinsky serves at the combat operations center for U.S. MACV.

March 21 – 1967 - The United States directs the Air Force to begin construction of the Infiltration Surveillance Center (ISC) at Nakhon Phanom Air Base, in northeastern Thailand. By 1968, the ISC becomes the monitoring location for Project IGLOO WHITE. This project deploys thousands of acoustic and seismic sensors designed to detect vehicles moving along the Ho Chi Minh Trail in Laos and Cambodia. ISC computers then sift through sensor data and pass it to analysts who assign air strikes against select targets. The ISC also mines sensor data to predict the times and routes of future convoys.

March 16, 1968 - Members of Company C, 1st Battalion, 20th Infantry, 11th Brigade of the U.S. Army 23d Infantry Division (Americal) murder up to 500 civilian men, women, and children in the hamlet of My Lai, Quang Ngai Province in I Corps. Army leadership outside of the Americal Division becomes familiar with the event in April 1969 when a U.S. Vietnam veteran writes to General Westmoreland and some congressmen, requesting an investigation. While Army public affairs officers release some information in September 1969, it does not receive widespread attention until journalist Seymour Hersh publishes a detailed account of the charges in November 1969. In the Army's investigation, 13 men are charged with committing these crimes. One, Lieutenant William Calley, is convicted of war crimes and sentenced to life in prison. *(See March 29, 1971 below)* The investigation also finds that the Americal Division's chain of command has suppressed reports of the incident.

March 31, 1968 - The Tet Offensive ends as the fighting in Hue subsides. It is a disastrous tactical defeat for Communist forces. As many as 50,000 Viet Cong and North Vietnamese soldiers have been killed, and the offensive achieves none of its major objectives. Viet Cong units are severely crippled and unable to mount new combat operations. The U.S. and South Vietnamese militaries lose more than 2,100 and 4,000 dead, respectively. The other allied nations suffer a total of 214 killed. An estimated 12,500 civilians are dead. Urban warfare in Saigon and other towns and cities produces hundreds of thousands of homeless refugees. Though the offensive is a tactical defeat for Hanoi, it earns Communist forces a strategic victory. The offensive stuns the American public and sows increased doubts about America's chances of winning the war.

March 18, 1969 - The United States conducts the first of a round of bombings against North Vietnamese and Viet Cong sanctuaries in Cambodia. These strikes evolve into the top secret bombing campaign known as Operation MENU, which lasts for 14 months. The Nixon administration hopes the bombings will demonstrate American resolve to Hanoi while also significantly reducing the flow of North Vietnamese troops and supplies into South Vietnam. The administration also believes that the campaign will increase pressure on the North to negotiate more seriously for peace. Although the bombings are a tightly held secret within the U.S. government and military, the New York Times breaks the story of the bombings on May 9. The possible leak prompts the Nixon White House to order wiretaps on the phones of journalists and administration officials, including an official in DoD. This and similar actions by the White House eventually lead to the Watergate scandal in 1972.

March 1, 1971 - A bomb explodes in the Capitol building in Washington D.C., near the Senate chambers. It causes an estimated \$300,000 in damage. No one is hurt in the blast. A group known as the Weather Underground claims credit for the bombing. The Weather Underground is a radical organization that advocates violence as a legitimate means to change American society. They assert that the bombing is in protest of the ongoing U.S.-supported South Vietnamese invasion of Laos.

March 29, 1971 - After a four-month-long court martial, Lieutenant William Calley is convicted of murder for his role in the My Lai massacre. He is sentenced to life in prison. Over time, Calley's sentence is reduced twice and he is ultimately paroled, released in 1974 and died April 28, 2024 age 80.

March 30, 1972 - The North Vietnamese launch the Nguyen Hue Campaign, also known as the Easter Offensive, with a multipronged attack across the DMZ and the Laotian and Cambodian borders into multiple regions of South Vietnam. The attacking forces are well equipped: armed with new weapons, heavy artillery, and tanks from the Soviet Union and China. It is the largest offensive launched by the North Vietnamese Army in the war. There are fewer than 70,000 U.S. troops left in Vietnam. U.S. military advisers play a crucial role rallying South Vietnamese units in retreat. After suffering heavy losses, the South Vietnamese army—with ample help from U.S. air support—slows and reverses the offensive by the end of the summer. They stabilize the front in Quang Tri Province and successfully hold out against attacks around Hue, Kontum, and Saigon. The North Vietnamese lose much of their armor and equipment and as many as 100,000 troops. South Vietnamese casualties are approximately 43,000, including 10,000 killed. The Easter Offensive also results in the deaths of about 25,000 Vietnamese civilians and leaves almost one million homeless.

March 14, 1973 - U.S. Marine Sub Unit One, 1st Air Naval Gunfire Liaison Company (ANGLICO) is formally deactivated, ending eight years of combat support for the South Vietnamese armed forces. Sub Unit One is the last Fleet Marine Force unit to leave Vietnam.

March 29, 1973 - General Frederick C. Weyand formally deactivates U.S. MACV. Included in this action is the deactivation of CORDS and the U.S. Navy, Air Force, and Marine Corps Advisory Groups, Vietnam.

March 24, 1975 - Having been evacuated by the South Vietnamese army, the old Vietnamese imperial capital of Hue falls to North Vietnamese forces. Many of the city's residents join the masses of refugees retreating south and east, to the coast, hoping for evacuation.

March 29, 1975 - North Vietnamese troops, having surrounded Da Nang days earlier, occupy the city. More residents stream to the airport and seaport, hoping for evacuation, and frantic refugees begin rushing planes as they land and take off—some even cling to landing gear. At the harbor, people pile onto large and small vessels while under heavy fire from Communist forces. Over five days, non-combatant ships of the U.S. Military Sealift Command take part in evacuating refugees from Da Nang south to Cam Ranh Bay. The SS *Pioneer Commander*, SS *Pioneer Contender*, USNS *Miller*, and several other vessels evacuate over 30,000 refugees. CIA-owned Air America also helps evacuate refugees by air. U.S. and allied vessels evacuate thousands of additional refugees from several other ports in I and II Corps.

#### THE CHRIS MULHOLLAND COMMUNITY SERVICE RECORD BOOK GUIDELINES

- 1. Record books should contain community service projects that are completed during the period May 1, through April 30.
- 2. FASTENER and COVER: If books have metal posts, steel is preferable to brass or aluminum. If covers have decals, place self-adhesive clear plastic over the decals so they will not be damaged during shipping and handling. Please use superior quality page dividers and index tabbing; the extensive handling that the record books experience must be considered.
- 3. CLIPPINGS AND PHOTOGRAPHS: Show dates and captions. Include supporting information.
- 4. ACCOUNTING OF EXPENSES: In a brief statement show how money was spent for each category (one or two pages at the most for each category).
- 5. ARRANGEMENT OF BOOK: Enter each project by category. (Chronological or month by month listing makes your entry more difficult for the judges to evaluate.)
- 6. ENTRY FORM: Complete and fasten inside front cover of volume one.
- 7. MAIL OR SHIP RECORD BOOK ENTRY FOR THE DEPARTMENT CONTEST to your Department Headquarters or the address they designate.
- 8. Avoid non-community service related items in your record book entry. Pictures of Post Officers, installation of officers, meeting, etc., will not be credited.

(This material should be assembled in a separate section and kept by the Post until the record book is returned after the competition, then it can be added to the record book for permanent reference).

#### **PREPARING A RECORD BOOK**

Posts and Auxiliaries carry on many projects which are of public service. The best way to tell the story of your Post and Auxiliary's work in the community is through a Community Activity record book that contains evidence of the many projects and programs your Post and Auxiliary perform.

The contents of your record book should be arranged and in such detail that it tells the story of each project, clearly and completely, to those who may read and judge it.

Posts and Auxiliaries should combine their community activity programs into one book or one set of books the Post and its Auxiliary are judged as a unit.

When making up a record book it is advisable to group your projects and programs into one of the seven categories. If a project qualifies for more than one category, select and list it under one category. It will be given credit, regardless of whether it is listed under the proper category.

For example:

Lite-a-Bike could be listed under categories five or seven.

Do not duplicate your efforts by placing them in each of the categories.

Remember, when compiling your community service record book you are telling a story of your work to judges who generally are not familiar with your efforts or community. The easier it is for the judges to read the facts, the easier it is for them to evaluate your work.

Some Community Activity record book entries have an additional index for each category which lists the subgroups within the categories. Some entries have an index only in the front of volume one.

Remember, also if you enter your record book in other competitions, the judges will be less likely to know about the VFW Community Activities Program. Just like composing a good letter, let your record book present the story so there will be no misunderstanding.

#### PREPARING A PROPOSED AMENDMENT TO THE NATIONAL BYLAWS, MANUAL OF PROCEDURE OR RITUAL

**Bylaws:** Any member in good standing, a Post, a District, or a Department, may propose an amendment to the National Bylaws; provided, however, before consideration at the National Convention, the proposed amendment must be approved by a Department Convention. Immediately following a Department Convention, the proposed amendment(s) must be forwarded to National Headquarters.

**Manual of Procedure and Ritual:** Any Post, District, or Department may propose an amendment to the Manual of Procedure or Ritual; provided, however, before consideration at the National Convention, the proposed amendment must have been forwarded, through channels and have been properly approved.

In order to meet National Bylaw/Manual of Procedure Article XIV requirements, to provide fifteen (15) day notice to all Posts of all amendments, the Adjutant General requests all amendments be forwarded to National Headquarters no later than five (5) working days following the close of the Department Convention.

# Bylaw, Manual of Procedure or Ritual changes not in proper form, unclear as to meaning, or concerning matters clearly not within the scope and purpose of the Veterans of Foreign Wars <u>cannot</u> be considered by the National Convention.

A proposed change to the National Bylaws, Manual of Procedure or Ritual must be submitted as such, <u>not as a</u> <u>resolution</u>. Proposed amendments must be <u>definite</u> and <u>specific</u> as to the verbiage to be deleted or added. Use of the most recent amended copy of the National Bylaws, Manual of Procedure and Ritual is encouraged, as proposed changes considered by Convention delegates cannot be amended on the floor.

#### EXAMPLE 1

Proposed Amendment to National Bylaws proposed by Department of \_\_\_\_\_\_. Section 202 – Bylaws.

Amend Section 202, National Bylaws, by deleting the words "two–thirds (2/3)" in the first sentence of paragraph one, and inserting, in lieu thereof, the following: "majority".

#### EXAMPLE 2

Proposed Amendment to National Manual of Procedure proposed by Department of \_\_\_\_\_\_. Section 518 – Officers: Duties and Obligations.

Amend Section 518, Manual of Procedure, by deleting paragraph (a) (1) d. in its entirety and inserting, in lieu thereof, the following:

"Plan and organize all social functions."

#### EXAMPLE 3

Proposed Amendment to National Ritual proposed by Department of

Amend the Ritual by deleting on page 48, in the last sentence of the Member's Obligation, the words "and a citizen of our great republic."

Further amend by placing a period after the word "comrade" in the same sentence.

If you require help composing a proposed change to the Bylaws, Manual of Procedure or Ritual, please contact Administrative Operations at National Headquarters for advice and assistance in properly preparing a proposed amendment to be voted upon by your department convention.

#### PREPARING A RESOLUTION TO BE CONSIDERED BY THE NATIONAL CONVENTION

The policy of the Veterans of Foreign Wars is established by resolutions adopted by the delegates attending Department and National Conventions. Most resolutions originate at the Post level and are passed through the District and Department before being acted upon at a National Convention. Many times, an otherwise worthy idea gets nowhere merely because it is not correctly presented.

A resolution contains two separate parts; a statement of the problem to be solved, and the proposed solution to the problem. The problem is outlined in the "*WHEREAS*" clauses, and the proposed solution is given in the "*RESOLVED*" section.

The "*RESOLVED*" section of a resolution should be complete in itself without depending on the "*WHEREAS*" clauses to give it meaning.

#### EXAMPLE

WHEREAS, the rising cost of living has created an intense hardship on those disabled veterans whose only income is a meager pension check; now, therefore

BE IT RESOLVED, that we petition Congress to enact legislation which would provide a substantial increase in non-service connected pension rates.

If a resolution deals with a local problem, it needs no action on a level higher than that of the Post. If the problem concerns an area larger than that served by the Post, it should, after Post approval, be presented before the District or County Council. All resolutions of statewide, regional or national concern must be acted upon by the Department Convention. Those resolutions approved by a Department Convention, which affect persons or matters <u>outside</u> the state boundaries, must be forwarded to the National Convention for final disposition.

When submitting a resolution to the Department Convention, a notation on the bottom should show the previous action taken, such as, approval by Post and, if applicable, by the District. A Post or District submitting a resolution to its Department Convention must follow guidelines established by the Department, which may require submitting the resolution to the Department Adjutant prior to the convening of the convention.

# Resolutions not in proper form, with unclear meaning, or concerning matters clearly not within the scope and purpose of the Veterans of Foreign Wars <u>cannot</u> be considered by the National Convention.

Resolutions approved by a Department Convention, which affect matters outside state boundaries, must be forwarded by the Department Adjutant to the National Convention for final disposition. Approved resolutions <u>should</u> be sent to National Headquarters at the close of the Department Convention. The Adjutant General requests all resolutions be forwarded to National Headquarters no later than five (5) working days following the close of the Department Convention. A resolution disapproved by the Department Convention or not acted upon by the Department Convention will not be considered by the National Convention.

Resolutions may also be originated by Department officers or by the Department Convention itself and acted upon by the Department Convention. A National Officer may originate a resolution concerning National affairs and submit it directly to the National Convention without Department action. Likewise, a National Convention Committee may originate a resolution and present it for approval during the National Convention. *Policy set by the National Convention is binding upon all subordinate units of the Veterans of Foreign Wars. No Post or Department is permitted to take any individual action or espouse any cause contrary to the National Bylaws or to the actions of the National Convention as outlined herein.*










#### Facts about The Barns at Blue Mountain: www.barnsatbluemountain.org

They are a 501c3 non-profit, they are a self-sustaining organization that relies on fundraising, donations, and grants to pay staff, care for their horse partners, monthly rent for their facilities, and all other expenses. They do work with Blue Mountain Therapy to provide quality services with their amazing staff. Their services are not billable to insurance companies currently. They are part of an army of equine assisted service providers working hard to supply hard data and results that will push companies to recognize the benefits and pay for these services. This is why they Fundraise so much! Their staff, board members, and volunteers work hard on raising funds all year to help cover the cost of services and care for their horse partners. They ask for no more than 1/3 of the cost of providing an equine assisted service from the family they serve. They have a sliding scale that can take the cost down to as low as \$5 per session. So fundraising and your support makes it possible to provide a trained & healthy equine partner, an equine specialist &/or certified therapeutic riding instructor, a therapist or counsellor in some cases, volunteers or added staff for aid, and the equipment and facility to those benefiting from our programs in your community. They work closely with Physical, occupational, and speech therapists, as well as, behaviour technicians, mental health professionals, and social workers from Blue Mountain Therapy. They collaborate and work closely with Emory & Henry College and their equine, psychology, and therapy departments to both put the most up to date methods into practice and to train upcoming equine assisted services professionals.

#### Programs they have:

**Healing Hooves** is a therapeutic riding program serving ages 6& up with a variety of physical & mental disabilities, or cognitive delays.

**Changing Strides** is an at-risk youth program serving ages 6-19. They work with DSS, foster care agencies, juvenile court, and mental health agencies to provide a safe space for healing and growth. They work on personal growth, healthy relationships and communication, and self-sufficiency.

**Serve a Purpose Program** serves our veterans, active military, and their families with both community engagement & support, and equine assisted psychotherapy with a mental health professional.

**Pony Power Reading Program** is for all ages and promotes reading and literacy while being in the calm realm of horses that is judgement free.

**Pony Pals Program** is an all-inclusive group class that is open to ages 6-15. This group learns horse safety, handling, behaviour, communication, independence, teamwork, social skills, emotional regulation, and leadership.

**Barn Buddies Program** is for adults with disabilities or cognitive delays to enjoy outdoor and social activities while learning social skills, emotional regulation, and independence.

I would like to begin by thanking Department Commander Rubenstein for letting the VFW Auxiliary Virginia provide Post Commanders and members information about forming a new Auxiliary and recruiting Auxiliary members for existing Auxiliaries.

#### Starting a New Auxiliary

The first step to institute a new Auxiliary begins with <u>Per VFW Bylaws Section XI -</u> no Auxiliary to a Post of the Veterans of Foreign Wars of the United States shall be formed unless approved by a two-thirds (2/3) vote of the Post membership present and voting at a regular or special meeting, due notice of the proposed formation of an Auxiliary having been given the entire membership of the Post, in writing at least twenty (20) days prior to a regular meeting, or special meeting called for the aforementioned purpose. The approval to form a new Auxiliary is to be reflected in the minutes of the meeting.

Although the process to form a new Auxiliary sound like a challenge, the benefits of having an Auxiliary affiliated with your Post far outweigh the challenge. You will have a partner to work with to assist the VFW to pass or block legislation that impacts veterans and their families, provide volunteer hours in the VA Medical Centers and local medical facilities, conduct patriotic programs with thousands of students and offer hundreds of thousands of dollars in scholarships for our nation's youth. We are there to assist Veterans and their families as well as working with other organizations in our communities.

#### **Existing Auxiliary**

If your post has an Auxiliary, you already know the benefits of having an affiliated Auxiliary. If you have not already done so, you can show your support by signing up eligible family members. The best resource for new Auxiliary members (must be minimum of 16 years old), either forming a new Auxiliary (which we need fifteen new members) or an existing Auxiliary is the Post members. Included is the VFW Auxiliary Eligibility which shows the relatives to the Veteran who are eligible to become an auxiliary member. If you would like to sign up new Auxiliary members, please contact the Auxiliary President. He or she will be happy to assist you.


