2. ACTIVE MEMBERSHIP:

The National Bylaws provide for only one type of membership: active membership. There are no provisions in the National Bylaws, nor is there any authority or justification for issuance of Club Membership cards, Associate Member cards, Honorary Membership cards, Courtesy Membership cards or any other special type of cards. Any Post issuing such unauthorized cards, or conducting club operations open to the general public, endangers its standing with the Internal Revenue Service as a non-profit organization. Officers signing outlaw cards admitting non-members to VFW premises are subject to disciplinary action. National and Department officers cannot defend practices that conflict with VFW Bylaws or procedures.

3. AUDIT REPORTS:

Attention of Post Commanders is directed to Section 218 (a)(11) of the National Manual of Procedure, Officers: Duties and Obligations. Trustees Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ended March 31.

4. AWARDS:

State Awards and All State information were in last month’s General Orders, along with various entry forms. Deadline is May 9, 2025, at 4:00 pm.

5. BUDDY POPPIES:

The price for the original buddy poppies (red ones) are \$160.00 per 500. The price for the metal poppies are \$70.00 per 500. As a reminder, poppies must be paid for before they can be shipped. A Buddy Poppy order form was in last month’s General Orders.

6. DELEGATE FEE:

In accordance with the National By-Laws Section 222(C), each Post will pay in accordance with Department By-Laws a delegate registration fee for each delegate to which the Post shall be entitled.

Therefore, you must submit your delegates list (form is enclosed) to the Department in accordance with Section 222 of the Manual of Procedure (B) along with a check in the amount of \$5.00 for every delegate your Post is entitled to as of membership status March 31. All delegate lists and monies should be sent to Department Headquarters by

June 11, 2025. Failure to do so will put your Post in arrears to the Department and the Post will have no voting strength at the State Convention.

7. DELEGATES TO DISTRICT/DEPARTMENT CONVENTIONS:

Pursuant to Section 403 of the National Bylaws and the Manual of Procedure, each District shall hold an annual District Convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention.

Pursuant to Section 403 of the National Bylaws – Regular Meeting, Districts shall hold at least two (2) regular meetings each year for purposes of transacting business and conducting schools of instruction.

Pursuant to Section 417 of the National Manual of Procedure, District officers shall not assume the duties of their office until the Department Commander is installed.

District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

10. E-MAIL ACCOUNT ACCESS:

All email accounts were reset so the new Officers could take control of their emails as of **June 21st**. This will be the primary means of sending correspondence from State Headquarters to Post and District Officers.

You will receive all General Orders, special notices and any other documentation that you need via email. This will help cut down on postal expenses and speed up the response time for you receiving the information.

Here are directions for logging into your new account for the first time.

1. Go to Department web site www.vfwva.org.
2. Click on Resources, Microsoft 365.
3. The username is your email address; put that on the first line (see below for your new address).
4. Your default password will be **VFW2024!** once you have accessed the mail program you will be asked to change it; it must contain at least one uppercase letter and one number.

For Post Officers, your address will be cdmpost176@vfwva.org where the 176 is you replace it with **your** Post number.

11. GENERAL ORDERS:

The cut off for the General Orders is the 20th of the month. No EXCEPTIONS. Subscriptions for hard copy General Orders are \$30.00 for the year. Contact State Headquarters for more info.

12. HALF-STAFF U.S. FLAG:

The U.S. Flag should be at half-staff on Memorial Day, the last Monday in May (federal holiday - half-staff until noon). Flags available at VFW Store vfwstore.org/category/flags/usflags.

13. FLAG DAY, JUNE 14:

All VFW units are reminded to properly display the U.S. Flag on Flag Day, Saturday, June 14 and to conduct a ceremony or program as feasible. You may contact the VFW Communications Department for a Flag Day

speech. It is also suggested Posts should award the VFW Patriotic Citizen Award (Product No. 4385) for those who have daily displayed our National flag.

15. INSTALLING OFFICERS:

Installing officers are directed to see to it that the Post Election Report forms have been completed and submitted to National Headquarters. If a Post Election Report form has not been forwarded to National Headquarters at the time of installation, the installing officer shall complete and forward such report at the time of the installation of Post Officers no later than June 1. **We encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS).** Post Election Reports received electronically will be forwarded to the Department Headquarters. Additionally, Section 413 of the National Bylaws requires that a properly completed District Election Report be submitted to National Headquarters prior to the convening of the Department Convention.

Post, District, Department Commanders, Adjutants and Quartermasters are reminded of the requirements of Sections 216, 416 and 516 of the Manual of Procedure with regard to proof of eligibility for all newly-elected and appointed officers. Elected and appointed officers **shall not be installed** or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Failure or refusal to submit proof of eligibility within thirty (30) days of election or appointment shall result in the office being declared vacant.

16. IRS FORM 8822-B:

IRS Form 8822-B, it is now a requirement by the IRS that all Posts submit this form. This form must be submitted anytime the Post Quartermaster changes and/or the Post address changes. This has been effective since January 1, 2014.

17. LIFE MEMBER DRAWING:

Congratulations to William I. Cooper Memorial Post 10574, Colonial Beach as the winner of a free Life Membership in the Veterans of Foreign Wars, Department of Virginia. Colonial Beach Post 10574 was made eligible for this Free Life Membership for having 100% of their membership reported to State Headquarters by March 28, 2025, deadline.

18. LIFE MEMBER PAYOUT:

The following will be the 2025-2026 Life Member Payout. The National Council of Administration concurred with the payment amounts at its March 2, 2025, meeting.

- Plan ABC - A total payout of \$10.50 for each life member (\$3.50 to each Post, Department and National).
- Plan D - A total payout of \$11.70 for each life member (\$3.90 to each Post, Department and National).
- Plan E - A total payout of \$23.10 for each life member (\$7.70 to each Post, Department and National).

Note: At-Large Members' corresponding plan pay out amount is divided by two. For example, Plan ABC At-Large Payout is \$5.25 (\$10.50 / 2, Department & National).

This information will also be placed in the VFW General Orders and other communications. As indicated in the By-Laws, payment will be made in September 2025 for all Life Members recorded as of August 31, 2025. In addition, a payment will be made in January 2026 for all Life Members processed during the period September 1 through December 31, 2025.

We wanted to get this information to you as soon as possible, because we know it affects your Post's budget projections for the ensuing year.

State Headquarters does not need a copy of your whole insurance policy; only a copy of the Certificate of Insurance listing State Headquarters and VFW National Headquarters as additional insurers.

The Certificate of Insurance needs to be sent to State Headquarters every year and it can be emailed to statehq@vfwva.org, faxed 1-866-416-0586 or regular mail to VFW State Headquarters, 403 Lee Jackson Highway, Staunton, VA 24401.

20. LOYALTY DAY AND MEMORIAL DAY OBSERVANCE:

Section 223 of the National Bylaws and the Manual of Procedure provides that each Post shall make the necessary arrangements for proper observance of Loyalty Day and Memorial Day. Officers should see that suitable grave markers, wreaths and flags of the United States are placed on the graves of deceased veterans.

21. MILITARY ORDER OF THE COOTIE:

The Military Order of the Cootie year starts June 1st and continues through May 31st each year. Your Cooties are conducting their Pup Tent elections for the upcoming year and will take command of their Pup Tents after the Grand Installation in June at the Department Convention. Cooties are out supporting Veterans in Hospitals and the grand special project of Equine Therapy. We have contributions going out to support Equine Therapy for Veterans

in the Richmond, Williamsburg, and Dale City areas. if you would like to contribute to this special project, please email me and we can discuss locations to contribute in your area.

The new Pup Tent 20 is getting closer to being initiated in Daleville, VA. To be eligible to be a Cootie you need to have completed six months in an officer position or active with your Post. Contact me for information regarding becoming a Cootie in the New Pup Tent.

22. NATIONAL CONVENTION:

The 126th National Convention housing officially opened March 18, 2025. Housing reservation information will be located on the convention website accessed through the main VFW website at vfw.org/convention. The convention website will also have general convention information including the registration form and links to other convention related information for Columbus, OH – Aug. 9-13, including a tentative agenda.

Section 222 of the Manual of Procedure states each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials, and one identified registered delegate for the VFW National Convention. Each additional delegate attending the National Convention will pay a ten-dollar (\$10) delegate fee provided the Post has paid the mandated \$25 advance registration fee. All advance registrations should be mailed to the VFW National Headquarters, 406 W. 34th Street, Kansas City, MO 64111. **ATTN:** Convention Registration, Quartermasters are strongly encouraged to register delegates utilizing the on-line membership system (OMS).

23. OFFICE CLOSURE:

State Headquarters and the State Service Offices located in Smithfield and Dale City are closed May 26, 2025, in observance of Memorial Day.

Please note the Norfolk Service Office is permanently closed.

24. POSTS IN ARREARS FOR FINANCIAL OBLIGATIONS:

Attention is directed to Section 213 of the National Bylaws concerning any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in County Council and District meetings; County Council, District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

25. REPORTING:

Comrades to view whether your Post has submitted an Audit Report, Americanism, Community Service, Safety, Youth or Hospital report you should visit the Department website (www.vfwva.org). The website is updated daily. If you have any questions, please call State Headquarters. There will be no form for Homeless when reporting for assistance to a homeless veteran please put it on a Community Activity report under aid to others.

26. RESOLUTIONS:

“Resolutions: Resolutions are the way the rank and file of the VFW can influence the organization’s priorities and processes. Program Resolutions, with the familiar WHEREAS paragraphs, are intended to bring decisionmaker attention to concerns (e.g., asking Congress to pass the PACT Act or asking the VFW National to implement a specific program). Resolutions to change By-Laws, Manual of Procedure, or Ritual take on a different format. For these proposals text to be added is underlined and italicized (and can even be **bolded**) whereas the text to be deleted is ~~struck out~~. An example of this type of resolutions was adding Vietnam Veterans Memorial Day to the list of special days of observance in the VFW Ritual. Please see the four-page Amendments and Resolutions Manual, in last month’s General Orders.

The time to submit draft Resolutions is **now**. Not only does this permit time for the Posts to work with the Resolutions Committee to smooth wording, focus logic and arguments, and identify sources of information, but it also prevents the Resolutions Committee from being overwhelmed in the week or two prior to the Department Convention, during which period, a late-submitted Resolution may not receive appropriate attention that it is due.

Posts can submit draft resolutions to the Committee prior to formal approval by Post membership so that logic and clarity of the arguments can be finessed and smoothed out. The Post can then vote on whether to approve the returned draft Resolution. Once formally approved by Post membership (at a Post meeting), the Resolution can be forwarded to State Headquarters, who will share with the Resolutions Committee. It is not necessary to submit a Resolution to District for approval, however, best practices suggest that the Resolution be socialized in order to garner necessary support for an eventual up/down vote at Department Convention.”

32. VFW DAY OF SERVICE:

Post/District Commanders, and Comrades,

One of the All-American Program requirements is to participate in the VFW Day of Service. This is how it's worded in the program book:

A Post must submit a community service report quarterly to their Department for submission to the All-American Dashboard. The quarters are July-Sept, Oct-Dec, Jan-March, and April-June. **One of these community service activities must be for the VFW Day of Service.** Learn more at: <https://todaysvfw.org/vfw-day-of-service/>

Even though it says to "submit a community service report quarterly **to their Department**", that's NOT how the VFW Day of Service is going to be recorded or tracked.

As per a conversation with Lynn Rolf, VFW Director of Programs, about what we may need to do to adjust our reporting from Virginia to handle this. He stated that Posts will be required to go to <https://todaysvfw.org/vfw-day-of-service/> and enter their event using the "Sign Up Now" button. So, not only do they need to report this directly to National, but it's reported differently than Patriot's Pen, Voice of Democracy, etc. There also will **NOT** be a way of seeing who has or hasn't reported their event on the National Dashboard. Unless something changes at National between now and then, this is how this new requirement will be handled.

The Department IT Committee Chairman Robert "Check" Adamczyk updated the All-State and All-American page on the State website to show where to report it, but the key thing is that there isn't going to be a way to track it.

Getting this news out to District Commanders and having them make sure the Posts understand this and when they submit the report to National. **The Day of Service starts May 3, 2025.** Since there will be no way for Districts or Departments to see who has and who hasn't met this requirement, it's going to be even tougher to track than usual.

33. VIETNAM WAR COMMEMORATION:

The following historical events for the Vietnam War took place during May:

1954 (May 6): Shortly before the final Viet Minh assault at the battle of Dien Bien Phu, two Civil Air Transport (CAT) pilots, James McGovern and co-pilot Wallace Buford, are killed when Viet Minh ground fire near Dien Bien Phu downs their transport plane. Over the course of the battle, 37 CAT pilots complete 682 airborne supply missions in support of the besieged French garrison.

1961 (May 14): The first unit of the Army Security Agency (ASA) arrives in South Vietnam, establishing headquarters at Tan Son Nhut Air Base. As the U.S. Army's signals intelligence branch, the ASA mission is to intercept Viet Cong and North Vietnamese electronic communications and use them to locate Communist troops. It designates its units as "Radio Research" to conceal their true purpose, and ASA personnel pose as military advisers attached to MAAG, Vietnam. The agency's personnel also train their South Vietnamese counterparts.

1964 (May 22): The CIA's Air America, formerly Civil Air Transport, begins search-and-rescue operations in Laos and North Vietnam. Its first rescue mission, on June 6, is an attempt to recover U.S. Navy aviator Lieutenant Charles F. Klusmann, who is shot down while flying a reconnaissance mission over the Plain of Jars, in Laos. Initial attempts to rescue Klusmann fail, however, and he is captured by the Pathet Lao. Klusmann later escapes and is picked up by Air America after three months in captivity.

1965 (May 3-7): The first U.S. Army ground combat unit to deploy to South Vietnam, the 173d Airborne Brigade, arrives from Okinawa. The brigade is stationed at Bien Hoa Air Base near Saigon. The 173d Airborne Brigade's initial mission is limited to defending U.S. bases and installations, especially Bien Hoa. This mission quickly expands in the following days and weeks to include offensive counterinsurgency operations against Viet Cong forces.

1965 (May 7): American officials and the U.S. Marine Corps restructure and expand Marine forces in Vietnam. The 9th Marine Expeditionary Brigade becomes the III Marine Amphibious Force (MAF). This force consists of the forward elements of the 3d Marine Division and the 1st Marine Aircraft Wing. The III MAF mission is to support the South Vietnamese in the five I Corps provinces, the vulnerable region closest to the DMZ. Before the end of June, 9,000 Marines are added to the Marine Corps forces in Vietnam.

1966 (May 10): The U.S. Coast Guard cutter Point Grey, patrolling off the Ca Mau Peninsula at the southern tip of South Vietnam, encounters a large steel-hulled trawler. The trawler runs aground when challenged. During the ensuing engagement, with assistance from the Coast Guard cutter Point Cypress and U.S. Navy personnel, the trawler suffers a large internal explosion. Salvage teams later recover tons of war materiel from the wreck of the trawler, which has been supplying Viet Cong troops in the area. It is the most significant known waterborne Viet Cong infiltration attempt since the Vung Ro Bay incident in February 1965. Also on that day, as part of Operation GAME WARDEN, the U.S. Navy establishes Mine Squadron 11, Detachment Alpha, under the command of Task Force 116. The squadron of a dozen minesweeping boats is assigned to keep the Long Tau River shipping channel clear of mines. The shipping channel is a vital avenue for merchant and military vessels heading to Saigon, and Viet Cong mining of the waterway would threaten to damage the economy of South Vietnam as well as the war effort, as the United States relies on the channel heavily to get goods and materials to Saigon.

1967 (May 15): Coast Guard Squadron Three, newly arrived in Vietnam, begins to support the U.S. Navy in Operation MARKET TIME. Squadron Three is equipped with five 311-foot, high-endurance cutters. In addition to providing fire support, Squadron Three interdicts enemy supply vessels and engages in medical and civic action programs. USCG Cutter Barataria conducts the first fire-support mission for Squadron Three on May 22.

1967 (May 31): The CIA's newly developed Lockheed A-12 reconnaissance aircraft flies its first covert surveillance mission over North Vietnam. It is the first of 29 missions named Operation BLACK SHIELD, whose primary objective is to photograph the sites of possible surface-to-surface missile installations. The CIA directs the BLACK SHIELD missions, which are flown by six pilots and three aircraft based in Okinawa. They determine that no surface-to-surface missiles have been placed in North Vietnam.

1968 (May 10): American and North Vietnamese representatives meet in Paris to begin peace negotiations. It is the first time negotiators from both nations meet face-to-face. Formal negotiations open three days later, but immediately come to a standstill. The two nations continue to hold talks until 1973.

1969 (May 10): In Operation APACHE SNOW, elements of the U.S. Army 101st Airborne Division, 9th Marine Regiment, and a South Vietnamese infantry regiment move to disrupt North Vietnamese activities in the A Shau Valley. The valley is an important enemy staging area for the Ho Chi Minh Trail. In an assault on Ap Bia Mountain on May 11, allied forces meet heavy resistance from multiple enemy battalions in fortified positions. Allied troops secure the mountain on May 20 after suffering significant casualties. American servicemen and journalists name it the battle of "Hamburger Hill." It is one of the bloodiest engagements of the war. APACHE SNOW concludes on June 7 and succeeds in forcing North Vietnamese troops out of the valley, but they return shortly after U.S. forces leave the area.

1970 (May 1): The U.S. Air Force and Navy fly the first large-scale strikes against targets in North Vietnam since the bombing halt of 1968. President Nixon orders them as "protective reaction strikes" in retaliation for North Vietnamese antiaircraft and SAM attacks on U.S. reconnaissance aircraft. Almost 500 American aircraft strike missile sites and antiaircraft emplacements over the course of four days. Officials at the Pentagon publicly acknowledge these strikes on May 3.

1970 (May 4): Antiwar demonstrations erupt on over 400 college and university campuses across the United States in the wake of the Cambodian incursion. Amid protests on the campus of Kent State University in Ohio, National Guardsmen fire at students. Four students are killed and nine are wounded. The shootings at Kent State become a focus of national attention and perhaps trigger as much outrage as the incursion itself, spurring the spread of demonstrations. Protests continue to break out nationwide over the following weeks, reinvigorating the antiwar movement.

1970 (May 9): A SEALORDS combined South Vietnamese-U.S. naval task force proceeds up the Mekong River into Cambodia as part of the Cambodian Incursion. Its main objective is to disrupt North Vietnamese and Viet Cong use of the river as an infiltration route into South Vietnam. The task force consists of river patrol, assault, and transport boats as well as helicopters and fixed-wing aircraft. South Vietnamese naval units reach the Cambodian capital of Phnom Penh. U.S. personnel are allowed only a short distance into Cambodia and stop halfway to Phnom Penh at Neak Luong, securing the strategic Highway 1 river crossing over the Mekong. U.S. boats return to South Vietnam by the end of June, but South Vietnamese forces continue to guard the Cambodian stretches of the Mekong through the summer

1970 (May 28): The National League of Families of American Prisoners and Missing in Southeast Asia incorporates in Washington D.C. The league emerges from a movement begun in the late 1960s in California and Virginia by the families of POWs. Its stated objective is “to obtain the release of all prisoners, the fullest possible accounting of the missing, and repatriation of all recoverable remains of those who died serving our nation during the Vietnam War.” The National League of Families becomes the largest of the POW/MIA family organizations and helps focus public attention on prisoner-of-war issues.

1972 (May 2): As part of the Easter Offensive, two North Vietnamese army divisions, supported by tanks and heavy artillery, launch an assault on Kontum, a key provincial capital city in the Central Highlands. The defending South Vietnamese forces are supported by U.S. Air Force air support and U.S. Army advisers, air cavalry, and attack helicopters. After two months of intense fighting, the allied forces defeat the North Vietnamese units and end the siege of the city.

1972 (May 9): In retaliation for the North Vietnamese Easter Offensive, President Nixon orders U.S. aviators flying A-7 Corsairs and A-6 Intruders from the carrier USS *Coral Sea* to begin mining the waters surrounding North Vietnamese seaports, including the vital port of Haiphong. Over 85 percent of the North’s military supplies flow through these ports, and the mines are intended to interdict the materiel powering the Communist offensive. The mining is labeled Operation POCKET MONEY.

1972 (May 10): In response to the Easter Offensive, The U.S. Air Force and Navy begin the massive aerial bombardment of targets in North Vietnam, known as Operation LINEBACKER. The bombings last until October, and their objective is to destroy or interdict North Vietnam’s military supplies in order to turn back the Communist invasion of South Vietnam. Targets include roads, bridges, military bases, power plants, warehouses, and petroleum storage facilities. President Nixon also hopes LINEBACKER will compel the North Vietnamese to negotiate an acceptable peace agreement. In LINEBACKER, U.S. aircraft drop over 150,000 tons of bombs in North Vietnam. The operation is the first sustained bombing campaign to extensively use laser-guided and electro-optically guided munitions. It helps stall the Easter Offensive and is one of the most effective campaigns of the war.

1972 (May 16): MAG 12 deploys to Bien Hoa to help provide air support to those allied forces countering the North Vietnamese Easter Offensive.

Comrades:

On March 18th your Council of Administration held a Special meeting to discuss vital business of the Department. As part of that meeting a discussion was held concerning the Service Officer Program.

The Service officer program for the Department of Virginia has taken a hit over the last few years. Having two Department Officers covering the entire state is not giving our veterans and their families the attention that they deserve to fully complete their claims. Therefore, the Council felt a need for a change. As of 1 April, our staff have been instructed not to take on any new clients or power of attorney's and begin the process of deferring all new claims to the Virginia Department of Veteran Services.

We have established a strong network and working relationship with DVS, which will give our members a larger pool to assist the veterans in every district. Our tax dollars are now funding 78 fully accredited full-time service officers and 21 administrative positions across the commonwealth now devoted to serving our veteran community. In addition, DVS also has a fully funded and staffed appeals team to represent Virginia veterans before the Board of Veterans Appeals and the U.S. Court of Appeals for Veterans Claims.

Due to fiscal realities the Council felt this was in the best interest of our veteran community. There is going to be a period of transition over the next few months, and we urge our members to be patient during this time. Our program will officially end on September 1, 2025, but the DVS will be there for our members starting April 1st, 2025.

This was a very difficult decision to make but one your Council felt was in the best interest of Virginia's veterans and their families.

My personal thanks go out to our dedicated VFW VSOs, Laurie Clay and Raymond Bailey, for their hard work over their time with the VFW. We look forward to their continued pursuits in serving our veterans.

Unusual language errors can indicate phishing attempts.

Check Sender's Email Address

Scrutinize the sender's email for odd variations or unfamiliar domains; legitimate emails usually have consistent, recognizable addresses.

Assess the Urgency and Tone

Phishing often uses a high-pressure tone demanding immediate action to create a sense of urgency.

Beware of Suspicious Attachments or Links

Do not open attachments or click links unless you're certain of their safety

Scrutinize the Email's Greeting

Impersonal or generic greetings might signal a phishing attempt.





Facts about The Barns at Blue Mountain: www.barnsatbluemountain.org

They are a 501c3 non-profit, they are a self-sustaining organization that relies on fundraising, donations, and grants to pay staff, care for their horse partners, monthly rent for their facilities, and all other expenses. They do work with Blue Mountain Therapy to provide quality services with their amazing staff. Their services are not billable to insurance companies currently. They are part of an army of equine assisted service providers working hard to supply hard data and results that will push companies to recognize the benefits and pay for these services. This is why they Fundraise so much! Their staff, board members, and volunteers work hard on raising funds all year to help cover the cost of services and care for their horse partners. They ask for no more than 1/3 of the cost of providing an equine assisted service from the family they serve. They have a sliding scale that can take the cost down to as low as \$5 per session. So fundraising and your support makes it possible to provide a trained & healthy equine partner, an equine specialist &/or certified therapeutic riding instructor, a therapist or counsellor in some cases, volunteers or added staff for aid, and the equipment and facility to those benefiting from our programs in your community. They work closely with Physical, occupational, and speech therapists, as well as, behaviour technicians, mental health professionals, and social workers from Blue Mountain Therapy. They collaborate and work closely with Emory & Henry College and their equine, psychology, and therapy departments to both put the most up to date methods into practice and to train upcoming equine assisted services professionals.

Programs they have:

Healing Hooves is a therapeutic riding program serving ages 6& up with a variety of physical & mental disabilities, or cognitive delays.

Changing Strides is an at-risk youth program serving ages 6-19. They work with DSS, foster care agencies, juvenile court, and mental health agencies to provide a safe space for healing and growth. They work on personal growth, healthy relationships and communication, and self-sufficiency.

Serve a Purpose Program serves our veterans, active military, and their families with both community engagement & support, and equine assisted psychotherapy with a mental health professional.

Pony Power Reading Program is for all ages and promotes reading and literacy while being in the calm realm of horses that is judgement free.

Pony Pals Program is an all-inclusive group class that is open to ages 6-15. This group learns horse safety, handling, behaviour, communication, independence, teamwork, social skills, emotional regulation, and leadership.

Barn Buddies Program is for adults with disabilities or cognitive delays to enjoy outdoor and social activities while learning social skills, emotional regulation, and independence.

I would like to begin by thanking Department Commander Rubenstein for letting the VFW Auxiliary Virginia provide Post Commanders and members information about forming a new Auxiliary and recruiting Auxiliary members for existing Auxiliaries.

Starting a New Auxiliary

The first step to institute a new Auxiliary begins with Per VFW Bylaws Section XI - no Auxiliary to a Post of the Veterans of Foreign Wars of the United States shall be formed unless approved by a two-thirds (2/3) vote of the Post membership present and voting at a regular or special meeting, due notice of the proposed formation of an Auxiliary having been given the entire membership of the Post, in writing at least twenty (20) days prior to a regular meeting, or special meeting called for the aforementioned purpose. The approval to form a new Auxiliary is to be reflected in the minutes of the meeting.

Although the process to form a new Auxiliary sound like a challenge, the benefits of having an Auxiliary affiliated with your Post far outweigh the challenge. You will have a partner to work with to assist the VFW to pass or block legislation that impacts veterans and their families, provide volunteer hours in the VA Medical Centers and local medical facilities, conduct patriotic programs with thousands of students and offer hundreds of thousands of dollars in scholarships for our nation's youth. We are there to assist Veterans and their families as well as working with other organizations in our communities.

Existing Auxiliary

If your post has an Auxiliary, you already know the benefits of having an affiliated Auxiliary. If you have not already done so, you can show your support by signing up eligible family members. The best resource for new Auxiliary members (must be minimum of 16 years old), either forming a new Auxiliary (which we need fifteen new members) or an existing Auxiliary is the Post members. Included is the VFW Auxiliary Eligibility which shows the relatives to the Veteran who are eligible to become an auxiliary member. If you would like to sign up new Auxiliary members, please contact the Auxiliary President. He or she will be happy to assist you.

To our "bachelor" posts once your post has approved the formation of the Auxiliary, please contact our Department President Dawn Kuhn or Department Chief of Staff Carol Vangi. We will assist you with the next steps.
