News Release

The Department of Virginia of the Veterans of Foreign Wars of the United States (VFW), the largest combat veterans service organization in Virginia, has gone on record to oppose any legislation restricting 2<sup>nd</sup> Amendment rights says the organization's State Commander, Eric Mallett.

Commander Mallett stated that at the VFW Virginia State Convention, representing over 32,000 members from across the Commonwealth, Delegates unanimously passed a resolution expressing their full support for 2<sup>nd</sup> Amendment rights as guaranteed by the Constitution of the United States of America. He further said that we oppose any attempt by the Virginia General Assembly to enact legislation that changes, alters, restricts or deletes any of those rights.

Commander Mallet stated, "Our Delegates and members feel very strongly about this issue and what they see as a continuing encroachment on the individual liberties and rights they fought to defend and for which many of their comrades died." The resolution cites "efforts in Virginia by some elected officials to infringe on our 2<sup>nd</sup> Amendment rights" and noted that those same officials "have ignored the wishes of Veterans, hunting enthusiasts, members of gun clubs and others."

All Veterans have taken an oath to support and defend the Constitution of The United States of America from all enemies, foreign and domestic. We continue that support and defense for the document as a whole and not just those parts that we might like or prefer. To do anything less would be a dishonor to those who have gone before us and a disservice to those that follow.

#### Virginia's Hal Roesch becomes VFW Commander in Chief

**KANSAS CITY, Mo.** – Hal Roesch II, of Hampton, Virginia, was installed as the Veterans of Foreign Wars' 112th National Commander on July 23 during a change of command ceremony at the VFW National Headquarters.

Roesch assumes command of the oldest combat veterans service organization boasting approximately 1.5 million members, including its Auxiliary.

"I stand before you, humbled, elated and ready to selflessly serve the 1.5 million members and its Auxiliary as we continue the tradition of serving America's veterans, service members and families worldwide," said Roesch.

Roesch is a 20-year U.S. Air Force retiree serving from 1982 to 2002. He earned his VFW eligibility during his combat service in Operations Desert Shield and Desert Storm and overseas service as part of Southern Watch. Roesch is a recipient of three Meritorious Service Medals, two Air Force Commendation Medals, two Air Force Achievement Medals, the Air Force Outstanding Unit Award with valor, the Armed Forces Expeditionary Medal, the Southwest Asia Service Medal with three campaign stars, and numerous other awards and decorations.

Roesch joined the VFW in 1991 at VFW Post 3034 in Sumter, South Carolina, and became a Post commander at VFW Post 4542 in Spring Lake, North Carolina. He now maintains his Gold Legacy Life membership at VFW Post 3219 in Phoebus, Virginia.

Roesch has served in elected and appointed positions at the Post, District and Department levels, culminating with his election as VFW Department of Virginia commander from 2008-2009. On the national level, he has served on the Council of Administration from 2010-2012 and as the inspector general from 2016-2017.

Roesch said the VFW is preparing to build a 20/20 Vision For

Veterans and it begins with re-educating and reintroducing the organization to its communities and local and national leaders.

"We are the pillars of our communities," said Roesch. "We represent the strength of our nation. And we will lead the charge into 2021 and beyond in protecting the very benefits and entitlements that our service members, veterans and military families have earned through their sacrifice, commitment and selfless service in defense of freedom."

Roesch said the VFW is more vital and instrumental today than it's ever been because of the veterans serving at Posts around the globe.

"Our VFW remains the resilient force it has always been," said Roesch. "We are stronger today because of you. Together, our voices will continue to be a dominant force in our communities, on the Hill and within the halls of the White House."

He also reinforced the organization's commitment to inclusivity stating, "Our doors are open to ALL eligible veterans, and today I stand here before you and personally invite all eligible veterans to join our organization." Roesch replaced William "Doc" Schmitz as National Commander.

#### Hal Roesch Homecoming Postponed

We are celebrating as our own Hal Roesch becomes Virginia's first Commander-in-Chief and we know he will lead us very well through this year. However, we cannot escape the fact that COVID will be a defining factor for this new VFW year like it was for the last year. Several states are seeing surging statistics related to COVID and we cannot put people at risk. With several VFW events impacted, this notice is likely not a surprise to many.

On Thursday, Dec.12, VFW Post 9835 in Warrenton presented awards to six students and three teachers from Fauquier County. The students were recognized for having the top entries in the VFW's annual patriotic student essay contests — Patriot's Pen (middle school) and Voice of Democracy (high school). For both, students entered essays on the topic "What Makes America Great." For an added challenge, the high school entrants presented their essays as a speech. Post Commander Jeff Dombroff said the Post received 58 entries from middle-schoolers in five of the county's schools and 12 recorded essays from students at four high schools, both public and private. The top three winners in each category were joined by family members and received certificates, medals and cash awards from the VFW. First-place winners in each age group read their winning essays to the packed meeting room at the Warrenton Visitor Center. The students recognized in the Patriot's Pen competition were: First place — Takiyah I. Pettie (sixth grade, W. C. Taylor Middle School) Second place — Ava E. Price (seventh grade, Wakefield School) Third place — Jane K. Brazy (seventh grade,



Wakefield School) The students recognized in the Voice of Democracy contest were: First place — Celeste A. Pollack (12th grade, Fauquier High School) Second place — Grant Freiling (11th grade, Fresta Valley Christian School) Third place Clifton J. Tooker (11th grade, Southeastern Alternative School In addition, Celeste Pollack's en-

try earned first place at District 8 level and is now competing for the state championship against the winners from the other 12 VFW Districts in Virginia. Post 9835 recognized the following teachers as Teachers of the Year: Arlene M. Thorpe, music teacher at C.M. Bradley Elementary School; Matthew Walker, civics and geography teacher at W.C. Taylor Middle School, and David J. Smith, Virginia and U.S. government teacher at Fauquier High School. Thorpe and Walker are also winners at the District 8 level and their nominations have been forwarded to the Department of Virginia to compete against peers from the other 12 Virginia VFW Districts. State winners were announced at the VFW Virginia Winter Conference in mid-January in Portsmouth VFW District 8 is comprised of VFW Posts in Warrenton, Manassas, Morrisville, Culpeper and Fredericksburg. Gary Robison,

quartermaster of Post 9835 introduced the winners. Since 2007, Thorpe has been the music teacher at C.M. Bradley Elementary School in Warrenton, where she has organized a chorus with students from the third through fifth grades. The CMB Singers have been invited year after year to sing the National Anthem at Family Day at the Potomac Nationals baseball field in Woodbridge. In addition, the students have performed at Gum Drop Square and in the Warrenton Christmas Parade. Each year Thorpe's third-grade students produce a "Salute to Veterans" on Veterans Day, and veterans from throughout Fauquier County are invited to attend. Robison said, that at the conclusion of the performance the students presented cards to the veterans in attendance and thanked them for their service. Matthew Walker is a seventh and eighth grade civics and geography teacher at W.C. Taylor Middle School in Warrenton. Walker goes above and beyond to give students a better and real life understanding of civics, citizenship and government. He has taken students on trips to the state capital in Richmond to meet and talk with our local delegate and to sit in the senate floor to see our government in action. He has arranged for local government officials to speak with and answer questions from his students. Robison said that Walker sponsors the Taylor Middle School Model United Nations student group and has inspired countless students to be successful citizens when they leave school. Robison quoted one of Walker's students: "He is kind, dedicated, creative, responsible, happy, polite, fun, a leader and a hard worker." David J. Smith has devoted the past 45 years of his life to teaching Fauquier County's young people, said Robison. A 1971 graduate of Fauquier High school (and a classmate of Thorpe), he has been teacher to fellow teacher of the year Matthew Walker and student speech winner Celeste Pollack. His lessons have always reflected patriotic values such as good citizenship and participation in civic life, Robison said, and his mock trials are legendary. Students take leadership roles in fictional trials and prove their cases in front of the judge, the Honorable David Smith. Robison pointed out that Smith is also the creative mind behind the website www.smittycity.org. In this age of internet connectivity, he has found a way to reach today's media-connected students that is fun, practical, informative and challenging.

#### VFW Post 9835 helps Veterans obtain Military Benefits

I enjoyed reading the article in the Health and Wellness section of the Feb 19 edition of the Times. And while the box listing "Help for Veterans" clearly stated that it was not a comprehensive list of organizations, I was disappointed to see that the Veterans of Foreign Wars was not among those listed.

The VFW, for more than a century, has led the way in obtaining benefits for America's military personnel and their families. In fiscal year 2019 alone, the VFW was instrumental in recouping over \$9 billion in VA disability and compensation benefits, including \$1.6 billion in new benefits for Virginia's veterans.

Through its Unmet Needs Program, the VFW can provide grants to eligible service members and their families facing a hardship due to deployment or military service. In Warrenton, Post 9835 sponsored four well-attended veterans benefits briefings and claims assistant sessions in 2019 and another was held this past January. One of the department's accredited service officers briefed attendees on the benefits available and assisted more than a score of veterans and family members in initiating paperwork to obtain needed and authorized benefits. Another such assistance session was held on March 18, 2020 at the PATH foundation.

#### Virginia VFW Post Receives National Community Service Award

#### Chesapeake Post 2894 rallied community together for a veteran's home renovation

Jun 29, 2020: KANSAS CITY, Mo. – The Veterans of Foreign Wars is proud to announce SSG Jonathan Dozier Memorial Post 2894 in Chesapeake, Virginia, was selected to receive the prestigious VFW Fred C. Hall Memorial Outstanding Post Special Project



VFW Senior Vice Commander-in-Chief Hal Roesch presented the 2020 VFW Fred C. Hall Memorial Outstanding Post Special Project Award to VFW Post 2894 Commander Chris Mulholland, alongside VFW Department of Virginia Commander Rick Raskin during the Department's convention.

Award, which recognizes VFW Posts for unique and outstanding community service projects.

VFW Post 2894 was selected for its home renovation project for Brandi Jones, a U.S. Navy veteran and single mother of two. After a traumatic home invasion forced her to move in 2011, Jones relocated only to discover her home would need more work than initially expected, but she didn't have the funds to address the growing list of concerns.

After a chance encounter during a VFW "Buddy"® Poppy drive, members of Post 2894 immediately set to work planning the renovation project. With support from several local businesses and associations, more than 150 volunteers rallied together to help ensure Jones and her sons had a safe place to call home. Valued at nearly \$25,000, the renovation project included new exterior floodlights and an alarm system, a completely remodeled kitchen, new flooring, fresh ceiling paint, a new roof, new siding and gutters, and a backyard clean up with new fencing and landscaping.

"When I challenged VFW members to 'Dare to Care' this year, the incredible level of support and dedication VFW Post 2894 showed their sister-in-arms goes above and beyond anything I could have imagined," said VFW National Commander William "Doc" Schmitz. "Post 2894's efforts are a perfect example of the values and mission of our organization."



### Mitchell L. Rubenstein Candidate for the Office of State Surgeon 2021-2022

Comrades my name is Mitchell Rubenstein and I am running for State Surgeon. I moved from New York to Virginia in 2010 and joined VFW Post 2447 in Edinburg August 2012 as a Life Member.
